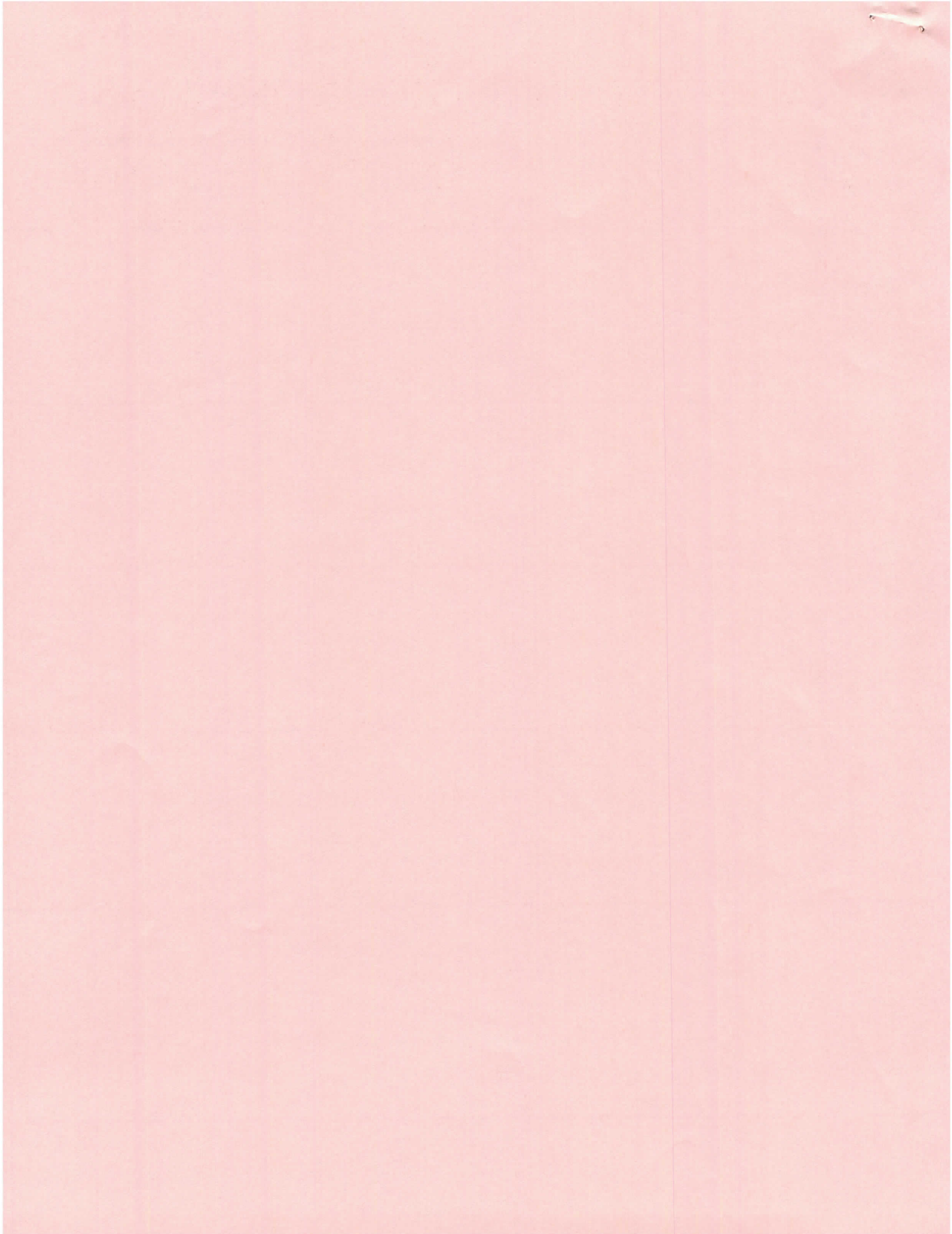

Japanese Envoy to Speak at CNC on May 2nd

At 1:00 p.m. on Friday, May 2nd, the Deputy Chief of the Japanese Embassy in Washington, D.C., will speak in A-105 on "Japanese-American Relations." All CNC Faculty and Students are cordially invited to be present to hear and meet Mr. Nachiro Kumagain, Envoy Extraordinary and Minister Plenipotentiary.

This event is jointly sponsored by the Virginia Peninsula Japanese-American Society and Christopher Newport College.

Prior to his appointment to the Embassy of Japan in the United States last August, Minister Kumagain served for two years as Consul General in Pretoria, Republic of South Africa. His other prior overseas assignments have included posts in Indonesia, the Republic of Korea, Malasia, the Federal Republic of Germany, and the United Kingdom. He received his law degree from Tokyo University in 1955, and later studied at Durham University in England.

Remembrance of Victims of Holocaust

United Campus Ministries will observe the annual Days of Remembrance of the Victims of the Holocaust on Wednesday, April 30, with hourly showings of the film, "To Bear Witness," in CC207, beginning at 9:00 a.m.

This 41-minute color documentary concerns the liberation of the Nazi concentration camps by the Allied Armies in 1945. It records the emotional reunions of survivors and liberators and explores the still-painful memories of those who survived the Holocaust and the men and women who liberated the camps.

Since its release in 1981, "To Bear Witness" has won numerous awards, including an Emmy, a Gold Screen Award from the National Association of Governmental Communicators, and the Gold Medal of the International Film and Television Festival of New York.

A bibliography of Holocaust materials contained in the Captain John Smith Library will be available.

Faculty and staff are cordially invited to take some time on April 30 to view the film.

NEH Youth Grant Project

Drs. Linda Hornback and Tim Morgan have been awarded an NEH Youth Grant to direct a project entitled "Recovering Black History in Isle of Wight County, Virginia: An NEH Youth Grant Project." The project will begin August 1, 1986, and will end October 31, 1987. Forty youths between the ages of 12 and 17 in the county's schools will be selected to participate. They will research, analyze, and write a monograph on black history in the county since Reconstruction. They will receive instruction and guidance in methods of traditional historical research, oral history, demographic analysis, photographic analysis, and historical archaeology, and then will use those techniques in recovering black history in the county. They will also prepare a major slide and talk presentation to be given throughout the county at the conclusion of the project.

Mrs. Jan Green, 1984 Social Work graduate and currently a Senior Social Worker for Gloucester County Social Services, (work telephone 693-2671) is running for National Office as Bachelor Social Worker Representative-At-Large in the National Association of Social Workers. The Social Work Program faculty are (literally) voting for Jan and hoping to see her attain this important and influential office in NASW. Below is Jan's background and platform statement, as it appears in the NASW News.

Biographical Data:

Jan Green, BASW, (Virginia Chapter) is a senior social worker at the Gloucester, Virginia Department of Social Services. A highly motivated family advocate, her attention is focused on social policies and programs concerning the juvenile justice system, the elderly, and child welfare in public social service agencies. She plans to establish a chapter unit in the Virginia Tidewater area. She has held progressively responsible positions in the Murray County (Virginia Developmental Center, most recently serving as interim executive director. She is a member of the Alpha Kappa Delta National Sociological Honorary.

Platform Statement:

The role of NASW in determining policies should be one strongly rooted in awareness and research. Awareness would serve the dual purpose of maintaining an adequate database and marshaling resources to promote its agenda. The research mandate would be to investigate areas of concern and to recommend viable approaches to involvement and interventions. Through awareness and research, a stronger voice is likely to emerge in the policymaking arenas. In fulfilling its advocacy role, NASW would be called upon to come to terms with how it perceives itself as a profession. Its influence must be extended to those isolated segments of our population which are subject to social and economic exploitation. We must come to an agreement of what is required of us and by use to be recognized as highly skilled professionals.

Health Benefits

As you may know, DentiCare has placed advertisements in many major newspapers throughout Virginia in the past few days. These ads are headlined "Attention State Employees and Retirees" and explain their dental plan, which is available throughout the state.

Please be aware that DentiCare does not have a contract with the State to provide dental benefits to state employees and retirees under a group policy. As a matter of fact, the company was an unsuccessful bidder in the recent competition for alternative health benefits plans. The company is acting independently, and any person in Virginia may or may not purchase his plan. They have no affiliation with the State health benefits program or with any of the plans which are under contract with the State to provide health benefits.

Effective July 1, 1986, the only State health benefits plans which offer a dental benefit are HealthAmerica and Keycare in the Tidewater area.
