Ph.D., Systems Engineering, University of Houston, 1975
Dr. Asai has a broad and strong academic background and has ten years of industrial experience in computer systems engineering with such organizations as Honeywell Information Systems, Lockheed Electronics Co., and STC LTV Aerospace. This experience has included participation in the analysis, design, and development of computer systems for NASA's Apollo, Skylab, and Space Shuttle programs. During the 1976-77 academic year, Dr. Asai held a full-time teaching position with the Mathematics Department at the University of Wisconsin. For the past ten years he has been involved in part-time undergraduate and graduate teaching for George Washington University, The College of William and Mary, and Michigan State University. In other summers he has taught graduate courses in banking and finance at the University of Tennessee and at Baruch College. In addition to presenting papers at many professional meetings, Dr. Karna has published in several prestigious professional journals including the Journal of Finance, Financial Executive, Financial Management, Journal of Business Research, and Journal of Bank Research.

During the period 1962-66, he was Assistant Professor of English at the University of Kansas; from 1966 to 1971, Assistant Professor of English at the University of California, Los Angeles; and during the period 1971-75, Associate Professor of English at Virginia Commonwealth University. Dr. Newell is the author of a book on poetry, and has had a score of articles published in cited journals.

Dr. Paul is currently an Assistant Professor of English at Northern Illinois University where he has served for seven years. She has recently been elected President of the American Alliance for Health, Physical Education and Recreation - the major national association for this professional area.
