Notice to the Faculty

As was announced by the Vice President for Academic Affairs at the Faculty Meeting on August 24, a plan for merit pay will be developed at C.N.C. Dr. Summerville quoted the following relevant section of the current handbook, "yellow," p. V-20 which states:

In the matter of financial remuneration to members of the faculty, the College is committed to the principle of equity and to rewarding exceptional service. It is also committed to the recognition of promotions and the achievement of additional academic degrees.

Following the determination of each annual budget, the college administration assigns, within the limits imposed by available funding, salary increases in accordance with the principles expressed above.

In identifying those members of the faculty who have rendered exceptional service to the College, the Vice President for Academic Affairs will consult with the Deans of the Schools, the Vice Chairman of the Faculty, and the Chairman of the Faculty Advisory Committee before making his recommendation to the President.

We both consider your guidance to us to be vital as we attempt to participate on your behalf in these decisions which will affect each of us on the Faculty. To that end, we solicit your input relative to the process by which merit pay may be instituted. As soon as we are formally contacted by Dr. Summerville, we will keep you informed concerning progress and specific proposals which are developed.

We feel that an open discussion meeting of faculty members on the general topic of merit pay and the interface between the faculty evaluation process and merit pay needs to be held at the earliest opportunity. To that end, we ask all members of the Faculty to at-

tend such a meeting on Friday, September 23 at noon in Gosnold 145.
