For the next biennium, Doris will be the vice-president of the Virginia Chapter of the AATSP.




Additionally, Marshall Booker is the chairman of a contributed paper session at the Eastern Economic Association meeting on Labor Economics and Manpower Development.



COMMITTEE REPORTS

Curriculum Committee

- 1. The Curriculum Committee voted to table the Expository Prose Competency Test in Writing proposal until further information is available. The Committee is sympathetic to the aims of the proposal but is unable at this time to resolve all the problems attendant in implementing the proposal.
- 2. The Committee voted unanimously to recommend to the Faculty approval of a cooperative program with Duke University leading to the professional degrees of Master of Forestry or Master of Environmental Management.
- 3. The following proposed change in the core curriculum and distribution requirements is recommended to the faculty by the unanimous vote of the Curriculum Committee:



There is no waiver of the core curriculum. Of the distribution requirements, two courses may be waived in one area, or one course may be waived in each of two different areas. No course above the 200-level shall serve as a core or distribution requirement. In the Social Science and Humanities requirements, no more than two courses can be offered in any single discipline. Courses taken in the major or minor fields may be offered to satisfy the core and distribution requirements if they are among the approved courses. There shall be no limit on the number of hours a student may take in the major field.
