COMMITTEE REPORTS

College Handbook Committee

The Committee's recommendation for Sections I-IV has been reviewed by the President. The President has made two substantive changes in these sections, both of which are in Section IV, Participation in College Governance.

(Change #1)

The President inserts on page IV-1 under the title Faculty:

The Faculty of the College are all those who are so designated by the Board of Visitors of the College. The Faculty includes the Teaching Faculty and Teaching and Research (T&R) administrators and librarians. The Teaching Faculty of the College is the body....

The President is making this change to allow T&R administrators and librarians, who have academic rank, greater participation in the formulation of college policies and to emphasize the collegeality among all sectors of the T&R Faculty.

This change has implications for policies and the Handbook Committee is reviewing these. Section V of the College Handbook will clearly delineate between policies which affect only the Teaching Faculty (e.g., tenure, evaluation, etc.) and those which affect all T&R Faculty.

(Change #2)

The President inserts on page IV-2 at the end of the paragraph on The Department Chairman:

The chairman is elected for a three year term by the members of the department, subject to the approval of the Dean, and serves at his/her pleasure.

The President makes this change to assure that the accountability of the Department Chairman to the Dean is clearly stated.

NOTE: Section I-IV of the recommendation of the Handbook Committee to the President is on reserve in the library.
