

Visiting Scientist Program/Virginia Academy of Science

The Virginia Academy of Science has a Visiting Scientist Program in which CNC will be participating next year. The program depends on the voluntary participation of our faculty members in visiting high schools to give talks, demonstrations, and assistance to teachers in the faculty members areas of expertise. Participants may be asked to respond to a request by visiting high schools within a 100-mile radius. No honorarium is involved, but all travel expenses will be paid by the College.

This year there were seventeen participants from CNC. Each of these participants is being contacted again regarding this possible participation this year. Other faculty are also invited to participate, whether the areas of expertise are in biological, physical or social sciences, mathematics, or some other discipline. In guiding your decision, please note that the stated purpose of the program is "to provide assistance in the teaching of biology, chemistry, earth sciences, mathematics, social science, and physics." If you are interested, please call Dennis Ridley (7392), or send your name, academic discipline, and lecture topic(s) through intra-campus mail. (If you participated last year, you will be contacted.) This information should be received by Friday, April 11, in order to make a timely response to the Virginia Academy of Science.

Approved Minutes of Curriculum Committee Meeting - February 26, 1986

The minutes of the meeting of February 19 were approved.

Old business: the articulation agreements with the community colleges and the issue of double counting.

The Committee passed a motion not to allow double counting.

Professor Greniewicki met again with the Committee to provide additional information on the proposed BSN degree. Matters discussed included background information on the development of the current proposal, the relationship of this program to other kinds of BSN degree programs, staffing, costs and methods of financing the program, and issues concerned with accreditation by the National League of Nursing.

Since the Faculty has already approved the program in general, the issue before the Committee was to vote on the course proposal for the upper level major. The Committee discussed the issues at length. Since Dean Durel and Professor Greniewcki will be having a meeting with Vice President Summerville which may provide additional relevant information, the Committee decided to postpone its vote until the next meeting and still allow enough time for Faculty consideration in March to meet the SCHEV deadline of April 1 for our statement of readiness.

From: Faculty Advisory Committee

Re: Impact of Position Reduction/FAC Responses

The FAC is primarily concerned with maintaining the vitality of the academic programs and academic quality of the College. Any decisions regarding faculty position reductions should be made only after careful consideration of the long-run impact on course offerings, enrollments, departmental majors and total FTE's.

We recommend that you consider the following in relationship to the academic programs and teaching mission of Christopher Newport College:

Short-term considerations (1986-1987)

1. Consider leaving some positions unfilled for which searches are being conducted. Examine positions case by case.

2. Study the advantages and disadvantages of adding new programs during a time of re-

trenchment, specifically the nursing program.

3. Examine the possibility of shifting faculty, administrators and classified employees to other positions or functional units. We should be willing, whenever possible, to retrain people who have demonstrated their value to the College. Some administrative positions might be part-time staffed with underutilized faculty.

4. Before taking potentially adverse action, review the impact of current school proposals to limit the number of introductory and upper-level sections, while significantly increasing their section enrollments and decreasing time-slot choices for our students. The ability of the College to generate student FTEs must be protected.

5. Consider the possibility that short-term disruptions in administrative and staff activities might be less damaging to the long-run health of the College (student enrollment figures, both in body count and FTEs) than reducing section offerings of courses normally in demand.

II. Long-term considerations

1. Develop measurable programmatic goals, with a balanced perspective on administrative and staff needs.

2. Examine the ratios among teaching, administrative and classified employees, with a

position-by-position "need analysis."

3. Study the impact of growing class sizes on instructional quality and ability to encourage enrollments, and find ways to curtail the use of mass lecture sections.

4. Increase the involvement of the teaching faculty in formation of policies which affect instruction and academic programs.

The FAC appreciates your efforts on behalf of the College during the past two "legislative" months. Once the final budget is known, the FAC would like to meet with you, the Deans, and the VPAA to discuss approaches to personnel position reductions before final decisions are made.
