



#### LIBRARY NEWS .

#### EXPANDED INTERLIBRARY LOAN SERVICE

With the beginning of Spring Term, 1977, Captain John Smith Library will extend its interlibrary loan privileges to students. This has been made possible by a courier service, which was instituted by the libraries of the Virginia Tidewater Consortium and which was funded by a State Council grant. Schools participating in the courier service are Christopher Newport College, William and Mary, Old Dominion University, Norfolk State College, Virginia Associated Research Campus, Eastern Virginia Medical School, and Paul D. Camp, Eastern Shore, Thomas Nelson, and Tidewater Community Colleges.

Both books and photocopies of journal articles will be available through the system, which will enable the library to procure requested materials available locally in from two days to a week. Borrowers will be expected to pay photocopy charges (charges to faculty will continue to be made against departmental budgets as has been done in the past). If requested materials are not available locally, in some cases the library will be able to borrow the material for students from schools outside the Consortium. Faculty borrowing outside the Consortium will not be affected by the new service.

Persons wishing to borrow materials through interlibrary loan should complete a request form, available at the library's circulation desk. Completed forms may be left here, and borrowed materials may also be picked up and returned here. Students will be limited to ten requests per week, and should be aware that charges and loan periods are set by the lending library, and may differ from the Smith Library rules.

#### Reserve Books

The library staff would like to remind the faculty that a 3-day notice is required to place books on reserve. This is necessary in order for the library staff to prepare the proper reserve book cards, to xerox material from journals and in some cases to call in the desired books.

It would also be helpful if faculty members would inform students that reserve materials would be available on the date which is three days forward from the date that the faculty member places material on reserve. In the past some enthusiastic students have turned up at the Circulation Desk to request material only an hour or two after faculty members have asked that it be put on reserve. The materials which the students requested were not available for their use, and this situation caused inconvenience for all concerned. We appreciate the cooperation of the faculty in this matter.



## The Academic Common Market 1977

Twelve Southern states\* participate in the Academic Common Market, an interstate agreement for sharing graduate programs. Residents of these states who are accepted for admission into selected out-of-state graduate programs can enroll on an in-state tuition basis. There are only two requirements:

Acceptance in a program to which your state has made arrangements to send its students;

Proof that you are a legal resident of that state.

Write directly to the institution for admissions information. After you've been accepted, write your state coordinator for certification of residency.
