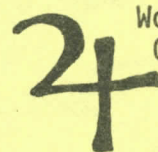

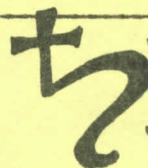

New Consortium Projects

Three new programs are in the process of development through the Virginia Tidewater Consortium for Continuing Education. The three programs are described below. Faculty members will receive more detailed information concerning these projects in Dean Musial's office.

(1) STUDENT CROSS-REGISTRATION. The Cross-Registration program is designed to permit students at any of the eleven Virginia Tidewater Consortium (VTC) institutions to take courses at any other VTC institution. When a student at a VTC home institution cross-registers at a VTC host school, the credit earned will be treated by the home institution as if it were earned at the home institution and will be so posted on the student's transcript as residence credit. student will not be charged additional tuition for a cross-registered course. The cross-registrant must assume cost of all transportation, books, materials, lab fees etc.

(2) FACULTY EXCHANGE PROGRAM. The Faculty Exchange Program would involve only faculty members who have full-time status at their home institutions. Arrangements must be agreeable to individual faculty members, their department chairperson, and the office of dean or academic vice president. Faculty exchange may occur only during the spring and fall semester, and does not have to be on a one-two-one basis.

(3) JOINT NON-TRADITIONAL DEGREE PROGRAM. This project proposes to develop a baccalaureate-level degree program which will be offered jointly by Christopher Newport College, Old Dominion University, and Norfolk State College and will be supported by Eastern Shore Community College, Tidewater Community College, and Thomas Nelson Community College. Particulars of the degree program involve a broad access admissions policy, a multi-faceted initial assessment procedure (including achievement batteries, preference tests, and analysis of previous course work), credit for non-collegiate experience, credit by examination, and the like. A panel of inter-institutional faculty members would be responsible for evaluating creditable experience as applies to the student's individual curriculum and degree plan. Mentors and learning contracts are central to the program. The program is still in its early stages of development. A description of the program has been sent to the Curriculum Committee for its review. The Faculty will have the opportunity to endorse or reject the program before any official commitments are made concerning CNC's participation.

A-V EQUIPMENT SCHEDULING

The current shortage of funds at the college has resulted in a cutback of the library's support staff. As a consequence, A-V delivery people will be obliged to service more locations than formerly, and delivery may not be as prompt as in the past. We hope that you will not be too inconvenienced during this time of budgetary reductions, which are difficult for us all.

If you need media equipment delivered, or if you have equipment (including projector reels and extension cords) which has not been picked up, please call the Media Assistant, Ava Jackson, at extension 7136.

Library regulations presently require a two day notice for delivery of A-V equipment, a three day notice for the placement of materials on reserve, and one day for photocopies. The library will try to maintain these minimum times, but faster service cannot be expected. The library appreciates the cooperation of the faculty with our efforts to provide the best service possible in spite of budgetary limitations.

The Virginia Foundation for the Humanities and Public Policy invites grant proposals from any non-profit organization, institution, or citizens group within Virginia. Twenty-eight (28) grants have been awarded during the current 1976-77 grant year, a total of 97 grants in the Foundation's first two and one half program years.

Approximately \$100,000 remains available for the period ending September 30, 1977, to support programs in the humanities on current public policy issues for adult community audiences. Workshops, conferences, seminars, town meetings, forums, and media presentations are among the activities eligible for funding.

ALL PROJECTS SUPPORTED BY THE VFHPP SHOULD:

- * Address public policy issues related to the current theme, "The Pursuit of Freedom and Equity" in the areas of politics, education, health, work, land use, or urbanization.
- * Involve the humanities - history, philosophy, literature, ethics, jurisprudence, the social sciences
- * Include teachers and scholars in the humanities in planning, implementation, and evaluation.
- * Be designed primarily for out-of-school audiences.
- * Promote objective discussion and help to clarify issues and priorities, encouraging participants to reach their own, informed conclusions.
- * Attempt to match equally a Foundation grant, either in cash or in-kind contributions.

COMMITTEE REPORTS

Admissions Committee

The Admissions Committee has requested that the Computer Center establish a single data base consisting of the two data bases of the Admissions Office and Registrar's Office. No new data would be accumulated in this new data base; the two data bases mentioned will be merged.

The Admissions Committee, in its last meeting, unanimously endorsed the following guidelines for use of the merger of data from the Admissions Office and from the Registrar's Office:

The use of a data bank by agents or agencies other than the Admissions Committee is not within the purview of the Admissions Committee and should be handled through normal channels (i.e., the Registrar's Office or the Admissions Office). Studies or reports made by the Admissions Committee will be conducted only with the approval of a majority of the Committee and should be consonant with the mission of the Admissions Committee (as found in the Faculty By-Laws). This should preclude studies aimed at the assessment of individual members of the College.
