minimum dollar amount per month established by the company for the total payroll deduction is now not being met. This means that unless more individuals participate, or those already participating increase their coverage, the company will begin charging individual rates rather than the very low group rates. The difference at this point is merely one or two additional participants to be able to continue the group rates.

The cost of this protection is approximately one-half of what you would expect to pay for similar coverage purchased on an individual basis. An additional feature is the family plan which will permit an employee to insure his dependent spouse and children at the same low rates. Applications for all those who enroll will automatically be accepted since there are no health questions. You may purchase this insurance in amounts ranging from \$10,000 to \$100,000. Benefits are paid in the event of accidental death and for loss of limbs or sight. You are covered 24 hours a day, 365 days a year anywhere in the world, whether you are at work or engaged in your own personal activities.

Premium payments will be arranged through payroll deductions.

We believe that this insurance is a very important part of our Employee Benefit Program and deserves very serious consideration as a part of your personal insurance protection.

Anyone interested, please see June Saunders, the Payroll Accountant, in Room 203 of the Administration Building for the necessary forms and to arrange for a monthly payroll deduction.

POSITION OPENING

Vice President for Academic Affairs - CNC

Christopher Newport College invites applications and nominations for the position of Vice President for Academic Affairs. The Vice President for Academic Affairs is responsible to the President for the academic program of the college.

CNC is a state-supported, four-year college located in suburban Tidewater Virginia. The academic areas of the College are organized in two schools--Liberal Arts, Sciences, and Education; Business and Economics--each administered by a Dean. The College has 110 full-time faculty members. CNC serves more than 4,000 full- and part-time students on its main campus and at several off-campus locations. The student body is composed of both traditional and non-traditional students--including large numbers of adults, military personnel, and veterans.

Candidates for the position must give evidence of the following qualifications:

(1) an earned doctorate; (2) full-time teaching experience at a baccalaureate, masters' or doctoral degree granting institution; (3) experience in academic leadership with major responsibilities at the level of Dean, the equivalent, or above; (4) experience in the development and control of budgets; (5) a commitment to academic excellence.

An annual (12 months) salary range of \$38,000-\$41,000. Position available July 1, 1982, but somewhat later starting date negotiable.

Candidates must submit a letter of application with specific reference to the applicant's experience in relation to the qualifications for the position (including a statement of the candidate's view of the nature of academic excellence) and a detailed curriculum vitae by March 1, 1982. Candidates should also have at least three letters of reference sent to the Search Committee by March 15, 1982. All application materials should be sent to Dr. Jouett L.
