

BACHELOR OF ARTS DEGREE IN FINE AND PERFORMING ARTS

A Bachelor of Arts Degree in Fine and Performing Arts is designed as an interdisciplinary degree in the arts and provides for specific concentrations in Theatre Arts, Fine Arts, and Music.

A candidate for a degree must take a designated introductory course in his selected concentration (Theatre Arts 210-211, Fine Arts 201-202, or Music 113-114) plus twenty-four additional hours above the 100-level in that concentration and six hours in each of the two disciplines.

To insure a coherent program with the inclusion of a suitable number of upper-level courses and a program that will support his educational and career goals, the student must plan his curriculum with faculty representatives of the three disciplines and must have their consent for his plan of studies.

Faculty Privileges at Swem Library


Negotiations are underway with the College of William and Mary to reinstate to the Faculty of Christopher Newport College the same privileges in the use of Swem Library as are enjoyed by the Faculty of William and Mary. We hope for a favorable response shortly.

Policies for Establishing New Degree Programs, Abolishing Programs and Majors, and Establishment of Departments

Last spring, the Faculty Advisory Committee recommended to the President and Dean that the policies and procedures which follow be approved. The Administration welcomed these recommendations and approved them.

"The ultimate authority over curricular matters rests with the President and is delegated to the Dean of Academic Affairs. The Faculty participates in a recommending role in the decision-making process when degree programs, majors, and minors are approved and departments are established or abolished.

Process for the Establishing and Abolishing of Degree Programs, Majors, and Minors*



Each level coordinates with the Dean of Academic Affairs as shown.

Each level recommends approval or disapproval and forwards it to the next level.

This same process, steps 1-6, should be followed when the following are proposed:

A. the establishing or abolishing of a minor.

B. changes in distribution requirements.

C. changes in requirements for degree tracks which affect departments other than the degree granting department.

For general information changes in the requirements for degree tracks that affect only the degree granting department should be brought to the attention of the Curriculum Committee and the Faculty through the Curriculum Committee.

Establishment and Abolishment of Departments

The establishment and abolishment of departments involves the administrative organization of the academic program, and falls within the authority of the Dean of Academic Affairs as delegated to him by the President.

Although the formal consent of the Faculty is not necessary for the establishment or abolishment of departments, the Dean of Academic Affairs will seek the input and counsel of the Faculty as is deemed appropriate in such matters. The formation or abolishment of a "paper" department will be communicated promptly to the Faculty and all offices of the College."

The Danforth Foundation **Associate Program** Nominations for 1977-1978

PURPOSE

The Associate Program seeks to recognize and encourage effective teaching and to foster activities which humanize teaching and learning for members of campus communities. It recognizes that learning includes the development of sensitivities and values, personal enrichment, and the cultivation of awareness and commitment to the broader community.

The Program offers distinctive opportunities for interdisciplinary and interinstitutional activities among faculty who share concerns for students as persons, and for values in education and in society. This network allows faculty to work collectively as well as individually with some of the issues facing educational institutions today.

Faculty at accredited four-year institutions who have a primary interest in teaching undergraduate students are eligible for appointment to the Danforth Associate Program. The major criterion for selection is that the person be a dedicated teacher, interested in scholarship, and an individual who seeks to improve faculty-student relationships. An Associate strives to integrate a concern for students, a concern for values, and an awareness of contemporary educational issues and their relation to society as a whole. The Program is designed to encourage individuals whose current activities reflect creativity and initiative in these goals. The Program is unique in the inclusion of spouses as full participants in program activities.

Nominations are solicited from students, faculty, administrators, and other Associates. A Liaison Officer and an Advisory Committee in each of the sixteen regions of the Program throughout the country assist in informing faculty about the Program. A national Advisory Council recommends the appointment of approximately 550 new Associates each year. Persons selected are notified during the spring, and their appointments begin June 1. Emphasis is placed on encouraging the nomination and appointment of women and minorities.

Appointment is for a six-year term. During this period, Associates are invited to three regional conferences with lodging and hospitality provided by the Foundation. The regional conferences are biennial and are held within the sixteen regions. Conferences are related to the Associates' roles as faculty, educators, and citizens, and are designed to develop their effectiveness as teachers and to strengthen their efforts to humanize the educational process. Conference activities deal with the basic theme of the Foundation in higher education: teaching and learning in a democratic society. Area conferences are available each year to complement the regional meetings.

Associates are eligible to apply for grant funds up to \$2,000 to assist in campus activities for projects related to improving the quality of teaching and learning.

Dear Dr. Davies:

The purpose of the attached material is to bring to your attention a major television event about the desegregation of schools.

Beginning Monday, September 19, and continuing for seven weeks through Friday, November 4, PBS, the Public Broadcasting Service, will feed AS WE SEE IT, a series of television programs which examines school desegregation from the students' perspective, to its 250 affiliated public television stations. Network feed time will be 5:30 P.M. Each public television station will decide whether it will broadcast the series, and if so, the time for broadcast. The local PBS station in your area can provide details.

AS WE SEE IT was produced by WTTW, the public television station in Chicago, under a contract supported by the television setaside of the Emergency School Aid Act (ESAA). Shows were filmed in 16 cities.

I hope you will help us make this series as widely seen as possible. I would appreciate your cooperation in distributing the material to the appropriate institutions.

THE VIRGINIA FOUNDATION for the HUMANITIES and PUBLIC POLICY is a non-profit foundation which supports educational programs in the humanities, focusing on current public policy issues, for adult community audiences. During its first three program years, the Foundation has awarded 130 grants, almost \$645,000, to a variety of non-profit organizations, institutions, and citizen groups throughout Virginia.

The Foundation believes that the humanities - history, philosophy, literature, ethics, jurisprudence, the social sciences . . - can provide a perspective that helps us understand topical issues, examine priorities, and explore alternatives. VFHPP programs seek to provide opportunities for citizens, policy makers, and scholars in the humanities to exchange views in a discussion of issues important to local communities.

OPERATION

An Executive Director and staff administer the program and advise those interested in submitting proposals. Grants are competitive and are awarded by a self-governing, non-partisan Board of 17 Virginians who meet three times each year to review applications.

The Foundation's operating and program budgets are supported by annual grants from the National Endowment for the Humanities, Washington, D.C., and by independent donors.

GUIDELINES

Complete guidelines and instructions for applications are attached. Programs should address public policy issues related to the current theme-"The Pursuit of Freedom and Equity" in the areas of politics, education, health, work, land use, or urbanization; promote an objective, educational discussion; and attempt to match equally a Foundation grant.

DEADLINES

September 1, December 1, and March 1

New grant proposals are welcomed for consideration following these dates. The Foundation invites consultation with the staff prior to submission of a complete proposal.
