

VIRGINIA FOUNDATION FOR THE HUMANITIES AND PUBLIC POLICY

On April 3 at 7 p.m. in the Campus Center, the Virginia Foundation for the Humanities and Public Policy is holding a regional meeting for the purpose of bringing together humanists and the general Peninsula community in order to discuss the special problems and interests of the State of Virginia. The VFH & PP is a re-granting agency of the National Endowment for the Humanities; its Board is in the process of deciding on a State theme, and after the theme has been decided, the National Endowment will give the VFH etc. an initial grant of \$150,000 (to be followed by more money later). The VF will in turn solicit proposals from humanists and non-academics that address themselves to the theme, and will award grants to the fortunate.

Virginia is one of the last states to involve itself in the state-based program of the National Endowment. The VF Board includes academics and members of the community; Edgar Shannon, President of U.Va., is the Chairman of the VF. Nancy McGhee of Hampton Institute and Frank MacDonald of William and Mary are also on the Board. Shannon, McGhee, and MacDonald will all be here on the 3rd, along with the Executive Secretary of the VF. Rob Vaughn.

We hope that Christopher Newport will be well-represented, not only by humanists but by those of our colleagues who have special interests in the Peninsula community. We apologize for planning a meeting in conflict with the Junior League (see last week's <u>Chronicle</u>), but we look forward to an interesting and productive meeting on the 3rd.

Graduate Fellowships

President Edgar F. Shannon, Jr., has directed that \$10,000 be set aside for graduate fellowships for faculty members at Virginia Institutions of Higher Education who have not yet earned their doctorates to do further graduate work at the University of Virginia during the 1974-75 and 1975-76 academic years.

To be eligible for one of these fellowships an applicant must be a resident of Virginia, have the support of his college or university for the fellowship, and have been admitted to graduate degree program at the University of Virginia. Applications for admission should go to the Deans of the Graduate School of Arts and Sciences, Engineering, Education Graduate Business, or Nursing, as appropriate. When applicants for admission have been advised that they will be admitted, they should write to David A. Shannon, Vice President and Provost, to apply for one of the fellowships. Their letters should be accompanied by a curriculum vitae and supporting letters from administrators at their institution. Dr. David Shannon will then submit the applications for these fellowships to a University Committee to make the final selections.

Dear Dave:

I would like to acknowledge your memorandum of March 27, 1974, requesting that no substantive changes in the organization of Christopher Newport College be implemented until the opportunity has been provided for consideration of the specific changes by the Faculty. I would like to assure you that this has always been the full intention of President Windsor and myself.

The only substantive changes planned for implementation in September deal with (1) the grouping of academic disciplines, (2) the authority, participation in decision-making, and functions of faculty and departmental officers at the departmental level, (3) the appointment of a new Assistant Dean, and (4) the operation of an Academic Council. None of these organizational changes will involve changes in the Faculty By-Laws.

As you know, the Organization Manual is still incomplete, and even those sections that already have been discussed by the Faculty are in the process of revision based on Faculty input. The "Goldenrod" document currently stands in several separate parts. I do not anticipate all sections coming back together until some time during the summer. President Windsor and I hope to have the entire Organization Manual together as a working document in September.

I would like to repeat my earlier remarks that the final version of those parts of the Organization Manual that rest within the authority of the Faculty will be determined by the Faculty.

Other sections of the document dealing with academic administrative offices represent, from my point of view, an attempt to spell out the authority, participation, and functions of existing administrative offices according to current practice in line with the By-Laws of the Board of Visitors, the By-Laws of the Faculty, and other operative College policy documents relating to the offices of the Dean and department chairmen.

But with respect to specific changes planned for the fall, it is President Windsor's and my intention to have pertinent revised sections of the proposed Organization Manual in the hands of the Faculty in the very near future.

If you have any further questions, I would be pleased to meet with the CNC Chapter of the A.A.U.P.
