COMMITTEE INFORMATION & FACULTY BUSINESS

Approved Curriculum Committee Minutes - 10/8/84

Present: Sanderlin (Chair), Powell, Olson, Royall, Mathews, Davidson, Durel, Park, Hunter King, Barbour (nv)

1. The 10/1/84 minutes were approved as corrected (item 6C, add "or Math 140 only" after the word "courses".)
2. Prof. Game of Computer Science requested a one week delay in presentation of the revision of the Information Science Degree. This was granted (Oct. 22nd deadline) on a motion by Olson (second Hunter). Dr. Sanderlin will inform the Computer Science Department immediately.
3. Curriculum Task Force Debate
 - A. On a motion by Hunter (second Durel) the committee unanimously approved the following motion:
All students must show quantitative skills proficiency as a requirement for graduation. Students should achieve and demonstrate such proficiency as early as possible in their courses of study. All students must pass a Quantitative Skills Proficiency Examination to be developed by the School of Letters and Natural Science. This exam must be completed before the 84th hour or upon admission after the 84th hour. The Quantitative Skills Exam should be completed as early as possible and MUST be completed before the 84th hour. The School of Letters and Natural Science is charged with developing a procedure to administer such exams.
 - B. On a motion by Olson (second Davidson) the committee unanimously passed the following:
The VPAA will conduct an evaluation of all Proficiency Exams after a two year period of use and at least every fourth year thereafter. Recommendations resulting from such evaluations will be brought to the Faculty through the Curriculum Committee as appropriate.
 - C. The Committee began a discussion of Degree Studies and Liberal Studies, centering primarily on questions regarding the Emphasis on Numbers within Degree Studies. No progress/actions to report.
4. The meeting adjourned at 5:00 PM. THE COMMITTEE WILL MEET AGAIN ON FRIDAY 10/12/84 at 1:50 PM IN N-203. Please review Appendices I&II of the proposal in preparation for Friday's meeting.

3. Taking up the discussion of the Degree Studies areas the following motions were passed unanimously.
 - A. On a motion by Durel (second Olson) the committee voted to create a third degree emphasis on Professional Studies, therefore having "Letters," "Sciences," and Professional Studies."
 - B. On a motion by Durel (second Olson) the committee voted in the "Sciences" degree area to require a two semester sequence in a different science selecting from Biology 101/101L-102/102;; Chem 103/105-104/106 or Chem 121/125-122/126; and Phys 103-104 with labs or Phys 201-202 with labs.
4. Meeting adjourned at 2:57 PM. Next meeting on Monday at regular time.
