

National Endowment for Humanities

Research Grants November 17 has been set by the National Endowment for the Humanities as the next postmark deadline for its Research Grants program. Grant assistance is provided for support of original thought, basic research, and editing projects in the humanities, including the social sciences that have humanistic content or employ humanistic methods. Special interest is given to projects that bear on major issues of contemporary public concern. Priority is also given to projects that may contribute to the Bicentennial of the American Revolution by reflecting major themes of the revolutionary era and contributing to a better understanding of the founding and development of the nation and its institutions. Applications from educational institutions must provide a minimum 10% cost-sharing. Projects submitted for this deadline should be scheduled to begin before August 1, 1975. Research Fellowships

For faculty interested in a fellowship to conduct independent study and research in the humanities. White House Fellows

December 2 has been set as the final date for receipt of 1975-76 White House Fellows applications. The program offers year-long fellowships to provide gifted U.S. citizens between 23 and 35 years of age in the Federal governmental and legislative process at the executive level. Fellows are assigned as aides to White House staff members, Cabinet members, the Office of the Vice-President, the Director of OMB, and other high-ranking officials. The first Visiting Scholar for the 1974-75 series will be Theodore J. Lowi of Cornell University. He will be speaking at the Campus Center Theatre on Wednesday, October 9, at noon.

A political scientist, Dr. Lowi has been the John L. Senior Professor of American Institutions at Cornell University since July, 1973.

He is the author of nine books, including The End of Liberalism: Ideology, Policy and the Crisis of Public Authority.

Lowi first joined the Cornell faculty in 1959 as an instructor in the Department of Government in the College of Arts and Sciences. He was named assistant professor of government in 1961 and moved to the University of Chicago in 1965 as an associate professor. He was named professor at Chicago in 1969.

The holder of the John L. Senior chair also holds the title of University Professor. Lowi also has joined the Departments of History, Government and of Policy Planning and Regional Analysis.

Born in Gadsden, Ala., Lowi was graduated from Michigan State University in 1954 with a bachelor's degree. He earned a master's degree in 1955 and a doctorate in 1961 at Yale University.

The author of some 50 articles on a wide range of topics in political science, Lowi's books include 'At the Pleasure of the Mayor: Patronage and Power in New York City, 1898-1958 (1964), Legislative Politics U.S.A. (1956) and "The Politics of Disorder (1971). Two books scheduled for publication within the next year are 'Arenas of Power: a Reconstruction of Politics" and 'Incomplete Conquest: American Government as a Problem of Politics.

Lowi has received numerous fellowships and honors, including a Guggenheim Fellowship for 1967-68, the 1962 J. Kimbrough Owen Award from the American Political Science Association and a Social Science Research Council Fellowship for 1963-64.

He has served in a professional capacity as a consultant to the National Commission on the Causes and Prevention of Violence (1968-69), as witness before the U.S. House Foreign Affairs Committee on several occasions and as a witness before the U.S. Senate Subcommittee on the Separation of Powers.

A recent article by Professor H. Marshall Bocker entitled "Academic Standards and Change," has been accepted for publication in the Journal of the Virginia Social Science Association. The article should appear in the November, 1974, or April, 1975 issue. Professor Booker also participated as a representative of Christopher Newport College in the activities of the Congress on Economic Integration in Budapest, Hungary, this past August. The project was organized in collaboration with the Hungarian Economic Association, and Professor Booker's Working Group studied the topic of The Integration of Less Developed Areas and Of Areas on Different Levels of Development.

Dr. Booker also was interviewed on the Jane Jordan-Tidewater A.M. TV show on September 19; the Dick Lamb TV show on September 12; and was the guest speaker at a breakfast for the Realtor Associates of Tidewater Virginia on September 24. Dr. Booker also will be the guest of WRVA-radio on Open for Opinion on October 1, in Richmond; the guest of Jane Jordan on WVEC-TV on September 29; and will be a discussant of a paper on What Classical Economics Owes to Classical Physics at the Atlantic Economic Association Annual Conference in Richmond on September 27.
