COMMITTEE REPORTS AND FACULTY BUSINESS

Minutes of the Faculty Senate of Christopher Newport College (unapproved)

Friday, February 17, 1989

The meeting was called to order at 2 p.m. by President Winter.

The minutes of the November meeting were approved as presented.

Information Items

The ACT-COMP has been administered for the purpose of assessment.

College Studies (CS) 101 will be suggested for temporary housing in the English Department.

The Faculty Fund presently totals \$232.

Lynda Whitley, the new Director of Public Relations, was introduced.

Implementation of the new Registration Model has been delayed until the new computer system is working smoothly.

A request to the Senate to consider changing the catalog policy for students to declare which requirements they will be judged by has been postponed.

Officer's Report

Vice President Colonna: encouraged consideration of early retirement buy-outs by the Faculty Senate of Virginia.

Committee Reports

The Academic Status Committee is considering the following:

- Policy of the College regarding withdrawal from a course and repeating a course;
- What actually constitutes enrollment in a course;
- Policy of the College regarding incompletes and the time frame for removal of incompletes;
- Catalog wording on repeating of a required or distribution course;
- Policy of the College on changing to audit.

The Committee meets again at 2 p.m. on Friday, February 24, in A-338.

The Curriculum Committee will be working diligently on new course proposals to complete its work in time for the deadline for the new Catalog. An Open Meeting will be called in connection with the proposed change in the College's Modern Language Distribution Requirement.

Old Business

Dawson moved (second: Bartelt) the following:

- The Faculty Senate recommends that each department, after consultation with its dean, propose a trade between overload and new full-time positions, if such a trade is desired by the departmental faculty.

.Approved unanimously.

New Business

Weber moved (second: Doane) adoption of four new courses:

- SOCL 301 Principles of Sociological Analysis
- FNAR 377 Contemporary Art
- FNAR 374 Arts of Asia
- FNAR 375 Primitive Art.

Approved.

Weber moved (second: Fellowes) that College Studies 101 be housed temporarily in the English Department. Approved.

Weber moved (second: Dawson) that the Director of Student Records be made a nonvoting member of the Curriculum Committee. Approved.

Doane moved (second: Dawson) that the Senate approve the following Faculty Development Grants:

- Prof. Saunders - \$207 for delivery of a paper in Staunton;
- Prof. R. Hubbard - \$901 for delivery of a paper in St. Louis;
- Prof. Morris - \$550 for conference attendance in San Francisco;
- Prof. Lopater - \$594 for conference in San Francisco;
- Prof. Matthews - \$650 for study in Mexico;
- Prof. Durel - \$1300 for study in Mexico;
- Prof. Weiss - \$564 for Chautauqua course in New Hampshire;
- Prof. Cones - \$564 for Chautauqua course in New Hampshire;
- Prof. Weber - \$810 for math research in Las Vegas.

Five proposals were recommended for denial. Approved.

Fellowes moved (second: Dawson) on behalf of the Degrees Committee that the following cases be approved:

Case 1- student petitioned to be allowed to use the second science sequence without labs to satisfy the general requirements for BSN. The student does have a sequence with labs. At the time course was taken lab was not required for RHSPN diploma.

Case 2- student petitioned to be allowed to use Psyc 201, 203 in lieu of Psyc 201, 202 to satisfy $\frac{1}{2}$ of social science distribution since that was the optional sequence upon entry.

- Case 3- student petitioned to be allowed to take six of the last 36 hours elsewhere under the "Permission To Take Courses Elsewhere." Request form on file.
- Case 4- petitioned to take approximately 12 hours of coursework at William and Mary (all electives) because of full-time employment there and transfer them back to complete degree requirements at CNC.
- Case 5- student petitioned to be allowed to use the second science sequence without labs to satisfy the general requirements for BSN. The student does have a sequence with labs. At the time course was taken lab was not required for RHSPN diploma.
- Case 6- petitioned to use a general CLEP in History to satisfy $\frac{1}{2}$ of social science distribution requirement as global. (The committee on Degrees does recognize this as acceptable).
- Case 7- petitioned to change from Social Work- 2+2 program to a major in Sociology with transfer program intact. The dean of SSPS and department chair recommend that this be done in this case.
- Case 8- petitioned to be allowed to present HLTH 200 to fulfill the LSPE distribution requirement rather than use the Spanish requested earlier and approved.
- Case 9- petitioned that the LL BIOL elective (anat. & phys.) taken in transfer combine with BIOL 213 taken at CNC and the CHEM sequence satisfy the natural sequence requirement for a BSN. All courses had labs. The courses also satisfied RHSPN diploma.

Approved.

Address and Discussion by President Santoro

The President reported on the following matters:

- the request for new faculty positions;
- the request for two new support staff positions;
- the request to convert 14 hourly positions to classified;
- the estimated budget shortfall of \$713,000 and measures, including a sizable increase in tuition, to offset it;
- new capital proposals under consideration.

During discussion of "the future of the CNC faculty," the President emphasized the following points:

- A starting assumption in any consideration must be that all currently employed faculty are acceptable.
- Terminal degrees are essential to the credibility of the College and should be required in conjunction with all future hiring.
- Present employees without terminal degrees will be helped, when appropriate, by being granted "grandfather" status.

- Given the danger of too many individuals moving into the rank of full professor, present criteria must be applied firmly.
- Nontenured, rotating slots should be considered to maintain flexibility.

Announcements

Prof. Pendergrass announced that a proposal to administer the IES closer to the end of the semester will be forthcoming.

Senate elections and School committee elections will occur in early March.

Business at the April Senate meeting will include the following:

- college-wide elections;
- recognizing the retiring Vice President for Finance;
- consideration of by-laws changes.

The Legislative Reception held on January 31 was highly successful. Most local legislators appeared. So did Governor Baliles.

Two CNC students are working as interns for Delegate Diamonstein this semester.
