NEWS & GENERAL INFORMATION

Legislative Update: January 30, 1986

Agnes Braganza has been in Richmond several days a week coordinating our contacts with the legislators. Let her know if you can go also.

The General Assembly members have filed all bills and amendments for this session. Subcommittees and committees of the House of Delegates and the Senate are in the process of deciding which issues will come before the Assembly for floor votes. All CNC matters are contained in the Budget Bill (House Bill 30 and Senate Bill 30) presented to the legislators by outgoing Governor Robb. We expect all parts of the Governor's budget that relate to CNC to pass both chambers without any reductions. Our efforts now center on amendments to increase the proposed allocations to CNC. On Friday, January 24, Delegate Alan Diamonstein submitted four amendments to HB 30 which will be decided by the House Appropriations Committee by February 15. On the same date, Senators Hunter B. Andrews, William Fears and Robert Scott have jointly introduced three amendments to SB 30 which will be decided by the Senate Finance Committee by February 13. Following the committee decisions, each chamber adopts its amended version of the budget. Differences between the two budgets are worked out in joint conference committee near the end of the session.

Amendments submitted in identical forms to both the House and Senate are:

- Restoration of 20.5 positions in FY 87 and 32.5 positions in FY 88, adding a total of \$900,906 to our biennial budget in general funds and \$386,103 in non-general funds for a total biennial increase of \$1,287,009. This amendment restores positions and associated mixed funds which were removed from CNC in the proposed budget and provides additional positions in the second year. In the budget listed above, on page 106, line 47, strike "10,966,769" and "10,671,766" and insert "11,434,772" and "11,490,772."
- Renovation of Lewis A. McMurran Hall. Capital expenditure appropriation of \$299,500 in general funds. This is to renovate the computer science area and to render the old book store space usable for the music program. This modifies the page 230 of the Governor's Budget at line 27, inserting "Renovations: Lewis A. McMurran Hall: \$299,500."

Amendment presented only to the House Appropriations Committee:

Planning funds for Phases I and II of a Physical Education Building. Capital expenditure appropriation of \$100,000 in general funds. This modifies page 230 of the Governor's Budget at line 27, inserting "Planning: Physical Education Building: \$100,000."

On January 30 I will participate in the testimony presented on behalf of these amendments before the House Appropriations Subcommittee on Higher Education. I urge prompt letters to members of our local delegation in Richmond or phone calls if you have a close relationship with your Delegate or Senator. If you know any members of the House Appropriations Committee or the Senate Finance Committee, please write to them. Otherwise, because of the large number of persons involved, you may write to the Chairmen and Subcommittee Chairmen. Letters to members of the House Appropriations Committee and the Senate Finance Committee should be sent as soon as possible since they are working on very tight deadlines. Please make your letters concise and limit them to the areas discussed above since other items will not be considered during this session.

Preliminary Report of the Dean of Admissions and Records: Spring Term 1986

Although the College's official census date for the Spring 1986 term is not until February 3, we are able to report some preliminary figures for this semester based on counts kept in the Admissions Office during the cycle now ending. These figures, of course, are subject to modification, based on the official reports we will receive after census.

- 1. Spring Enrollment. As of January 24, it appears that the College has enrolled 4,012 students this Spring for an FTE total of 2424. One year ago the College enrolled 4087 students for an FTE total of 2444. The decline, smaller than anticipated, appears to have occurred chiefly in off-campus enrollments. Of greater significance is the fact that it now appears probable that our traditional fall-to-spring decline in FTE enrollments will only be at about the 6% level or one-half to 1% better than is customarily the case (-6.85% in 1984 and -6.47% in 1985). As of this writing (1-27-86) this seems to have been so because of an increase in applications for admission and new enrollees this spring over one year ago.
- 2. Spring Admissions. Preliminary reports indicate that we have now processed approximately 1242 applications for admission this spring compared with 1119 one year ago. This
 figure represents an increase of 11% and is the first such increase in applications we
 have experienced in three semesters. Further, it appears that 1017 new students have
 been enrolled as a result of these applications—this compared with 918 new students
 enrolled a year ago and, therefore, an even more significant increase. There is some
 indication that these increases have occurred primarily in degree-seeking transfer students, but we will not know this with certainty until census.
- 3. Annual Admissions. It now appears that the current academic year will see a very slight, but nonetheless real, increase in the total number of new students admitted and enrolled as compared with the 1984-85 year. This increase in new enrollees is summarized as follows:

Fall 1984 (1799) + Spring 1985 (918) = 2717 Fall 1985 (1727) + Spring 1986 (1017) = 2744

While such an increase is hardly cause for celebration, it does suggest that overall enrollment shortfalls continue to be the result primarily of student attrition and declining off-campus programs rather than our capacity to attract new students to the College's on-campus programs (although, in this regard, we are still down from our strongest year, 1983-84). On the other hand, it remains to be seen whether or not our increases this Spring have resulted from the desire of some to enter the College now before the new curriculum goes into effect next Fall.

Additional analysis of this year's activities will follow when the information becomes available to us.
