

COMMITTEE REPORTS

Faculty Benefits Committee

After careful study of possible benefits the following memorandum was sent to President Windsor. His response follows this memo.

TO: President James Windsor

FROM: Faculty Benefits Committee (Professors Booker, Boyd, and Morris

We would like to see the three following items considered for inclusion as faculty fringe benefits at Christopher Newport College. (#3 statewide)

1. Sick Leave/Disability Insurance Protection

Sick leave/disability leave would be payable at 100% of the contract in force at the time for the duration of the contract term or six months, whichever is the longer. After that date, disability leave would be payable at 75% of the beforementioned contract for a total of four years from said date.

2. Tort and Liability Insurance

a. Comprehensive General Liability - Would cover all members of the faculty while acting within the scope of their duties, including personal injury (libel, slander, false arrest, false charges, etc.) and bodily injury. For instance, if a student and the faculty member is held negligent and/or responsible, the policy would provide protection.

Coverage (minimum) \$500,000 Bodily Injury - Each Occurence \$500,000 Bodily Injury - Aggregate \$ 50,000 Property Damage - Each Occurence \$ 50,000 Property Damage - Aggregate

b. Legal Liability - Covers liability arising out of errors of omission, malfeasance, and wrongful acts not related to bodily injury or property damage.

Coverage (minimum) \$ 250,000 - Each loss \$1,500,000 - Aggregate loss

To include coverage of all legal fees and costs surrounding defense of those claims covered under the above.

3. Dependent Tuition

After five years of full-time teaching at a state institution of higher learning, the dependents of such qualified employees would be granted a tuition waiver at the undergraduate level, of a reciprocal nature at any Commonwealth/ State supported institution of higher education.

I will discuss these suggestions with the personnel office in Richmond and will let you know what I learn. I believe such provisions could become effective only if implemented on a state wide basis.



Faculty Advisory Committee

- I. The meetings of the President's Administrative Council held on April 14 and 28 were attended by the Chairman of F.A.C. Items of note included:
 - A. The President's announcement that a special open meeting of the C.N.C. Board of Visitors will be held on July 1, the first day of our independence from William & Mary. At that time, the Board of Visitors will act on a resolution to accept formally the organization of the College and to reaffirm all actions of past Boards of Visitors. Mr. Harrol Brauer, Rector of the Board, will address the invited guests. Faculty members are encouraged to attend this significant event in our history as an institution of higher education. The exact schedule for this day will be announced at a later date.
 - B. On May 25, Governor Godwin and a group of advisors will visit C.N.C. After a twenty minute presentation, President Windsor will conduct the group on a tour of the campus to include the trailers.
 - C. FORMS MANGAGEMENT PROJECT

 President Windsor shared a letter written by Gordon Davis,
 Acting Director of SCHEV to Mr. Robert R. Ramsey, Jr.,
 Secretary of Education, suggesting that a meeting take
 place between representatives of higher education and the
 Dept. of Management Analysis & System Development to discuss
 the implementation of the Forms Control Project. Mr. Davis
 told Mr. Ramsey, "that the implementation plan developed by
 MASD will place a great workload on Virginia's colleges and
 universities, a workload entirely disproportionate to the
 magnitude of the forms control problem the plan seeks to
 solve."
 - D. On August 13 we will hold our last summer graduation.
 - E. Mike Stamen reported that he had been directed to implement portions of the Va. Privacy Protection Act 1976 which require the location of all college files which contain personal information. The kind of data contained in each must be reported to the State.
- II. The F.A.C. recommended the following process to President Windsor for implementation at the beginning of the academic year 1977-78. Information copies were given to the Curriculum Committee and the Dean of Academic Affairs.



Each level coordinates with the Dean of Academic Affairs as shown.

Each level <u>recommends</u> <u>approval</u> or <u>disapproval</u> and forwards it to the next level.

This same process, steps 1-6, should be followed when the following are proposed:

A. the establishing or abolishing of a minor.

B. changes in distribution requirements.

C. changes in requirements for degree tracks which affect departments other than the degree granting department.

For general information changes in the requirements for degree tracks that affect only the degree granting department should be brought to the attention of the Curriculum Committee and the Faculty through the Curriculum Committee.

III. The F.A.C. endorsed the recommendation of the Department of Mathematics that the title of Professor Emeritus be awarded to Professor Daisy Bright at the May 15 graduation to mark her retirement from C.N.C. This recommendation was forwarded to Dean Edwards and President Windsor.

IV. STATEMENT TO GOVERNOR GODWIN

At the faculty meeting on May 6, the statement to Governor Godwin urging the funding of the 4.8% salary increase will be circulated again. At this writing over fifty faculty members have signed. The statement is also available for signature in Wingfield 223.
