Virginia Motor Vehicles Registration

From the Virginia Code 46.1-41.1. Temporary exemption for new resident operating vehicle registered in another state or country. A resident owner of any passenger car, pickup truck, or motorcycle, other than those provided for in 46.1-43, which has been duly registered for the current calendar year in another state or country and which at all times when operated in this Commonwealth has displayed upon it the license plate or plates issued for such vehicle in such other state or country, may operate or permit the operation of such passenger car, pickup truck, or motorcycle within or partly within this Commonwealth for the first thirty days of his residency in this Commonwealth without registering such passenger car, pickup truck, or motorcycle or paying any fees to this Commonwealth. State Council Funds for Excellence Awards

At the State Council meeting of May 4, 1988, CNC was awarded funds for two proposals that were submitted under the 1988-90 Funds for Excellence program. Doc Powell received \$87,491.00 for his proposal, "Advising as Acculturation: A Program for CNC Freshmen." This project will develop an enhanced advising program which will address the special needs of advising and acculturation for non-residential freshmen students. John Hoaglund received \$72,554.00 for the proposal "Faculty and Curriculum Development in Critical Thinking." This grant will improve the teaching of critical thinking skills throughout the CNC curriculum by providing special instruction to selected faculty members, who will then share this knowledge with others in their departments. We would like to commend Bob Durel and Terry Maris for the very fine proposals each submitted under this competition; unfortunately, SCHEV did not fund them this time.
