# State Travel Regulations; Paragraph . 160:

"MEALS may be reimbursed when an employee is traveling on non-daily routine official business outside his official station. These expenditures must be kept reasonable and are also subject to question by the Comptroller. Any unusual charges must be explained fully on the travel voucher, although it is understood that meal expenses may vary with the area traveled. Employees engaged in constant daily routine travel are not reimbursed for meals (present exceptions withstanding.) In some instances, evening meals associated with approved memberships for organizational meetings are reimbursed by the State. If meals are included with registration or lodging as part of a package plan, note the number of meals and whether they were breakfast, lunch, or dinner on the reimbursement voucher. An employee who is required to work on a nonwork day such as Saturday, Sunday or holiday may claim reimbursement for meal expenses if the Agency allows such expenditure.

LUNCHEONS or noon meeting expense related to organizational memberships will not be reimbursed by the State. This includes any State agency luncheon group."

#### Change in Medicare Enrollment Guidelines

Employees who are or will soon be turning 65 should be aware of recent revisions in the Medicare enrollment guidelines so that they will not lose health care benefits.

As of January 1, 1982, persons who do not sign up for Medicare within three months of turning age 65 may only enroll for Part B of Medicare during the general enrollment period (January, February and March). Coverage will be effective the following July 1.

When you reach age 65 or over and have not signed up for Medicare, you should sign up for Part A immediately. Medicare Part A (hospital coverage) can become effective retroactive to the first of the month that you turned age 65 but no more than six months retroactively. You should apply for Medicare Part B (medical coverage) during the earliest general enrollment period.

The State's Blue Cross and Blue Shield contract does not cover any services that can be covered by Medicare. It is important that employees and their dependents sign up for Medicare promptly or benefits will be lost.

#### Pass/Fail Grades

There are courses listed in the <u>CNC Catalogue</u> which are stipulated as being graded on a Pass/Fail basis. Students also have the option of taking on a Pass/Fail basis 2 courses in their senior year outside of their major which are regularly graded A through F.

A student may take as many courses that are stipulated in the <u>CNC Catalogue</u> as being graded on a Pass/Fail basis as he or she wishes as well as the <u>senior option</u>. It is the senior option which is restricted to 2 courses.

# Israeli Law Professor at CNC On Wednesday, March 24th

Dr. Shimon Shetreet, Senior Lecturer, Faculty of Law, Hebrew University will visit CNC the morning of Wednesday, March 24th. At 9:00 A.M. he will speak in AlO5 on "Freedom of Conscience and Religion in Israel," and at 11:00 in W109 on "The Judical System in Israel."

During the noon hour on March 24th, Dr. Shetreet will interact with faculty and students in N115. This will be an informal dialogue (brown bags welcome) on "Democracy and Civil Rights in Israel."

Dr. Shetreet holds LL.B. and LL.M. degrees from the Hebrew University of Jerusalem (1968 & 1970), and M.C.L. and D.C.L. degrees from the University of Chicago (1971 & 1973). He has held academic positions at universities in West Germany, England, the United States and Canada. In addition to numerous articles concerning ethnic divisions, the judiciary and the legal system in Israel, Dr. Shetreet is the author of two books: Judges on Trial (1976), and Freedom of Conscience and Religion (1978). He has appeared frequently on Israeli radio and television, and in the Israel press, as a legal commentator and writer on social and political affairs.

In addition to representing Israel at numerous international legal conferences, Dr. Shetreet is the Labour Party representative to the Central Elections Committee, and is a member of the Labour Party's Central Institutions and Operational Committees.
