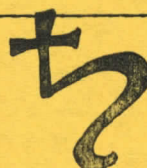

### CNC/ODU Affiliated Nursing Program

Near the end of the past summer, Christopher Newport College and Old Dominion University completed formal agreements making it possible for registered nurses to earn the ODU Bachelor of Science Degree in Nursing by taking all of their non-nursing courses at Christopher Newport College. A complete description of the Program is available in the Dean's Office.

The Program is the result of several years of planning. The Affiliated Program with ODU was proposed after we concluded last year on the basis of an HEW-sponsored feasibility study that it was not possible for CNC to develop its own independent nursing program at this time. While only registered nurses are eligible to enroll in the CNC/ODU Affiliated Program, it is our hope that we may offer a generic nursing program sometime in the future in cooperation with ODU for students who have no nursing background but wish to pursue the B.S.N. degree.

### New Degree in Interdisciplinary Studies

Last May, the State Council for Higher Education approved the new Bachelor of Arts/Bachelor of Science Degree in Interdisciplinary Studies at Christopher Newport College. Students may enroll in the program this fall. In the near future, I will be meeting with an ad hoc committee consisting of John Avioli, Ruth Kernodle, Al King, Liz Jones and Bill Parks for the purpose of planning the procedures for administering the new program and advising students who wish to enroll. Until appropriate guidelines are established, students who are interested in the program should be referred to the Office of the Dean of Academic Affairs where they will be asked to complete a brief form describing their proposed program of study.

### Dossiers

According to the "Standards" document (Faculty Handbook, V-5) it is the responsibility of department chairpersons to keep individual dossiers and to see that they are kept up to date for purposes of annual peer evaluation. During the past two years, however, dossiers have routinely been returned to individual faculty members, and I believe there is a statement somewhere in the Faculty Handbook describing this as the usual practice. I hope that confusing guidelines on this matter have not led to any serious inconveniences.

All individual dossiers were returned to the appropriate department chair-



person early in June. Some were in turn passed on to individual faculty members while others were not.

To remove possible ambiguities, I would like to reaffirm the guidelines of the "Standards" document: It is the responsibility of the department chairperson to maintain the dossier of each member of his department. The individual faculty member may add to his dossier at any time, but the chairperson will return the dossier to the individual faculty member only at the time for updating prior to the individual's next peer evaluation.

#### Travel Reimbursement

Reimbursement for the actual cost of travel on official business of the State government is authorized to be paid from appropriate funds. For the use of personal automobiles in the discharge of official duties outside the continental limits of the United States, the Governor may authorize an allowance not exceeding the actual cost of operation of such automobiles. For the use of personal automobiles in the discharge of official duties within the continental limits of the United States, notwithstanding any other provision of law, the reimbursement shall be at the rate of 15¢ per mile or, in the instance of a State employee, the amount charged by the Central Car Pool unless the head of the State agency concerned certifies that a State-owned vehicle was not available or that he considers use of a personal automobile to be of advantage of the State. Such reimbursement shall be paid only if the travel and costs have been incurred in accordance with uniform regulations issued by the Governor and with the requirements set forth below.
