1989-90 BEST YEAR IN CNC ATHLETIC HISTORY

To put it very simply, it was the best year in the history of Christopher Newport College athletics.

CNC athletes and teams accounted for an unprecedented number of awards, championships and records, and truly placed the entire athletic program among the best in the nation in NCAA Division III.

Among the most outstanding accomplishments:

- * All but one CNC team finished with a winning record.
- * CNC's overall record of 148-78-2 was the best in Virginia among all 23 Division II and III colleges when forfeited games were taken into account.
- * Individuals or teams representing seven of CNC's 15 NCAA teams appeared in national championship competition.
- * A total of 12 athletes, representing seven different teams, won a total of 27 All-America citations.
- * The women's track team won yet another national championship, running its streak to six consecutive titles.
- * CNC teams won six conference championships and finished second seven times.
- * Christopher Newport won the Dixie Conference President's Cup, symbolic of overall athletic supremacy in the conference, for the fifth time in the last seven years.

A quick rundown of the major accomplishments of each team:

The soccer team had the second best record in its 16-year history, with an 11-5-2 mark.

In volleyball, the Lady Captains finished 14-17, but took second place in the Dixie Conference Tournament. Senior Paula Hockster became the first CNC athlete ever to receive Academic All-Region honors when she was named to the All-Region III team. That earned her name a spot on the Academic All-America ballot. She was also second team Academic All-Virginia in competition with every college athlete in the state regardless of sport or division.

Cross country runner Des Proctor finished 17th at the NCAA Division III National Championship, making him CNC's second cross country All-America in history.

The men's basketball team earned a berth in the NCAA Division III National Championships for the fourth time in five years, and had the second highest number of victories in its 23-year history (19). Junior Lamont Strothers was named honorable mention All-America, and became the fifth highest scorer in Virginia Division III basketball history with 1,950 points.

The Lady Captain basketball team shared the Dixie Conference regular season championship with Greensboro College, and then won their second Dixie Conference Tournament championship. They closed the season with a 17-9 record.

The women's indoor track team won its sixth consecutive national championship, and captured the prestigious Mason-Dixon Conference title as well. That conference includes teams from Divisions I, II and III. Senior Sheila Trice captured two individual national championships, in the 55 meters and 55 meter hurdles, and earned five All-America awards. Also earning All-America recognition were senior Michelle Dickens, sophomores Jennifer Martin and Barbara Robb and freshman Jeannette Brown.

Junior Ed Milling became the first male CNC national champion by capturing the 55 meter title at the NCAA Division III Indoor Track National Championship. The Captains placed second in the Mason-Dixon Conference Championship.

In baseball, the Captains had their greatest season ever with a 20-14 record, including four victories over teams ranked among the top six in the nation in Division III. Junior Tab Pabst was named second team All-America pitcher, and senior Gary Malarkey was third team All-America first base. They were the first two CNC baseball All-Americans.

The CNC softball team posted an amazing 28-7 record, by far its best ever, and won the Dixie Conference regular season championship. The Lady Captains 28 wins were the second highest number of victories ever recorded by any CNC team. The 1985 volleyball team had 32 wins.

The Lady Captain outdoor track team placed sixth at the national championship, ending its streak of six consecutive national titles. Sheila Trice won the 100 meter championship for the third consecutive year and ran her career totals to an incredible 14 national championships and 32 All-America awards. Jennifer Martin, Barbara Robb, Jeannette Brown and Cynthia Bryant all also earned All-America recognition. CNC also won the Mason-Dixon Conference title.

Freshman Tony Rodriguez represented the CNC men's outdoor track team at the nationals, finishing ninth in the triple jump.

The men's tennis team won the Dixie Conference championship for the eighth time, but the first since 1983, as junior Matt Allen, sophomore Dave Scheiderer and freshman Holden Knight all won singles titles. Scheiderer and freshman Robert Downen combined for a doubles title.

The women's tennis team placed second in the Dixie Conference Tournament, and served as host of the event.

The golf team tied for 11th place at the NCAA Division III National Championship in its first appearance as a team. Sophomore Joe Monk tied for 10th place individually to earn second team All-America honors. He is the second CNC All-America golfer.

SUBJECT: Meal Reimbursement Documentation Requirements

The following meal expenditure reimbursement documentation policy is effective July 1, 1990:

- A restaurant or charge card receipt must accompany reimbursement requests for each meal expenditure of \$25 or more. This policy applies to all meal reimbursements, whether on travel status (day or overnight travel) or reimbursable business meals. Each meal expenditure of \$25 or more must be listed on a separate line on the Travel Expense Reimbursement Voucher (DA 02-041).

This policy is necessary in order to conform to new Internal Revenue Service regulations. These regulations require documentary evidence to support meal expenditures of \$25 or more. The absence of such documentary evidence requires the meal reimbursement amount to be reported as gross income to the employee. The Commonwealth Accounting Policies and Procedures Manual and the State Travel Regulations Pocket Guide will soon be revised to reflect this new policy.

Although this may not allow sufficient time to notify all travelers, please implement this policy as soon as reasonably possible. If we can provide any additional information, please contact Mr. David A. Von Moll, Manager, Pre-Audit and Compliance, at 225-3071 (SCATS or local).
