What is STIS?

STIS is an electronic dissemination system that provides fast, easy access to National Science Foundation (NSF) publications. There is no cost to you except for possible long-distance phone charges. The service is available 24 hours a day, except for brief weekly maintenance periods.

What Publications are Available?

Publications currently available include:

- The *NSF Bulletin*
- Program announcements and "Dear Colleague" letters
- General publications and reports
- Press releases
- NSF organization charts and phone books
- NSF vacancy announcements
- Award abstracts (1989—now)

Our goal is for all printed publications to be available electronically.

Access Methods

There are many ways to access STIS. Choose the method that meets your needs and the communication facilities you have available.

Electronic Documents Via E-Mail. If you have access to Internet or BITNET e-mail, you can send a specially formatted message, and the document you request will be automatically returned to you via e-mail.

Anonymous FTP. Internet users who are familiar with this file transfer method can quickly and easily transfer STIS documents to their local system for browsing and printing.

On-Line STIS. If you have a VT100 emulator and an Internet connection or a modem, you can log on to the on-line system. The on-line system features full-text search and retrieval software to help you locate the documents and award abstracts that are of interest to you. Once you locate a document, you can browse through it on-line, or download it using the Kermit protocol, or request that it be mailed to you.

Direct E-Mail. You can request that STIS keep you informed, via e-mail, of all new documents on STIS. You can elect to get either a summary or the full text of new documents.

Internet Gopher and WAIS. If your campus has access to these Internet information resources, you can use your local client software to search and download NSF publications. If you have the capability, it is the easiest way to access STIS.

Getting Started With Documents Via E-Mail

Send a message to **stisserv@nsf.gov** (Internet) or **stisserv@NSF** (BITNET). The *text* of the message should be as follows (the Subject line is ignored):

get index

You will receive a list of all the documents on STIS and instructions for retrieving them. Please note that all requests for electronic documents should be sent to **stisserv**, as shown above. Requests for *printed* publications should be sent to **pubs@nsf.gov** (Internet) or **pubs@NSF** (BITNET).

Getting Started with Anonymous FTP

FTP to *stis.nsf.gov*. Enter *anonymous* for the username, and your e-mail address for the password. Retrieve the file *index*. This contains a list of the files available on STIS and additional instructions.

Getting Started with the On-Line System

If you are on the Internet: **telnet stis.nsf.gov**. At the login prompt, enter *public*.

If you are dialing in with a modem: Choose 1200, 2400, or 9600 baud, 7-E-1. Dial 202-357-0359 or 202-357-0360. When connected, press Enter. At the login prompt, enter *public*.

Getting Started with Direct E-Mail

Send an e-mail message to **stisserv@nsf.gov** (Internet) or **stisserv@NSF** (BITNET). Put the following in the text:

get stisdirm

You will receive instructions for this service.

Question: What's been called the fastest ten minutes on the Peninsula?

Answer: The annual Writers' Reading Program at Christopher Newport University presented by the Office of Continuing Education.

If you haven't a clue, then let me clue you in.

This is the third year that area writers have been reading their works at the CNU "Writers' Reading - Poetry & Prose" Program, held on selected Friday evenings from September through March in the Campus Center Terrace.

The next meeting of the 1993-94 season will be held Friday, November 5, 1993 at 7:00 p.m. in the Terrace, CNU Campus Center.

Writers wishing to read should contact the Continuing Education Office at 594-7158, to secure a place on the program for this first meeting. The following guidelines have been established to give all readers equal time:

1. Readers must read their own original work.
2. Readers will have exactly ten minutes to read and will be interrupted at the end of ten minutes.

This restriction has posed a problem for many readers in the past and the following suggestions are presented to enable readers and their works to be shown to their best advantage:

1. Poets should choose only those poems which fit the allotted time.
2. Nonfiction writers should select a short essay or article, not to exceed ten minutes.
3. Fiction writers should choose carefully a small portion of the story they have written, preceding their reading with a synopsis leading into that portion, again, the presentation in its entirety, not to exceed ten minutes.
4. All readers are urged to time their reading at home, aloud, prior to their performance. If you can't say it in ten minutes, you can't say it!
5. Because of the number of writers interested in reading their works, it has been suggested that writers not schedule themselves to read at two consecutive meetings.

- * Bob Saunders has written an article entitled "History, Health and Herons: The Historiography of Woodrow Wilson's Personality and Decision-Making" which will be published in a forthcoming edition of the Presidential Studies Quarterly. Arthur S. Link of Princeton University has been asked by the editors of the journal to respond to the issues raised in the article.

Marquez, Modern & Classical Languages & Literatures presented a paper at the XI International Literary Symposium on Postmodernism held at the National Library of Uruguay in Montevideo, Uruguay, and the University of Buenos Aires, Argentina, August 9-14, entitled "Causality and Its Theological-Political Dilemmas: A Grounding of the Cuban Revolution by Jose Lezama Lima."

He read several poems at the poetry reading "North and South: A Meeting of American Voices," at the University of Buenos Aires, Argentina, August 13.

Marquez has been included in an Anthology of Modern Cuban Poets, ed. M. Robles, UNISA Centre for Latin American Studies (Pretoria), and the University of Natal in Dunbar, South Africa.

His article "Nature and History in Jose Lezama Lima," appeared in Annals, University of Barcelona (Spain).

Park's article entitled "Japanese Direct Investment in the United States: An Analysis of Critical Trade Variables and the Changing Patterns in 1990's," appeared in the publication of Asian Economic Journal (Journal of the East Asian Economic Association), Vol. VI, No. 3, Shatin, N. Dr. Park also reviewed the article entitled "Economic Systems of North and South Korea from The Biblical Perspective," for the Journal of Comparative Economics and submitted comments for the journal.

ANNUAL COMPETITION FOR FULBRIGHT AND OTHER GRANTS TO CLOSE SOON -- The 1994-95 competition for grants for graduate study abroad offered under the Fulbright Program and by foreign governments, universities, and private donors will close on October 31, 1993. Only a few more weeks remain in which qualified graduating seniors and graduate students may apply for one of the approximately 700 awards to over 100 countries.

Most of the grants offered provide round-trip transportation, tuition and maintenance for one academic year; a few provide international travel only, or a stipend intended as a partial grant-in-aid.

Applicants must be U.S. citizens at the time of application, and must generally hold a bachelor's degree or its equivalent before the beginning date of the grant, and, in most cases, should be proficient in the language of the host country. Except for certain specific awards, candidates may not hold a Ph.D. at the time of application.

Creative and performing artists are not required to have a bachelor's degree, but must have four years of professional study or equivalent experience. Candidates in medicine must have an M.D. or equivalent (e.g., O.D., D.D.S.) at time of application.

Application forms and further information for students currently enrolled at Christopher Newport University may be obtained from the Fulbright Program Advisor, Dr. Sanford Lopater, who is located in Wingfield Hall-118A. The deadline for filing an application is October 11, 1993.

The University

Christopher Newport University is concerned about the safety and welfare of all members of the CNU family and their guests, and is committed to providing a safe and secure environment. Located on a major public transit line, Christopher Newport University enrolls 5,000 undergraduate and graduate students, and employees 330 full-time and 200 part-time employees. The Christopher Newport University campus consists of 12 buildings situated on a 75-acre suburban tract in midtown Newport News, Virginia.

Because no campus is isolated from crime, the University has developed a series of policies and procedures that are designed to ensure that every possible precautionary measure is taken to protect people and property on campus. To help prevent incidents of crime, the University operates a full-time, professionally-trained University Police Department.

University Police

The University Police Department, which enforces federal, state, and local statutes and Christopher Newport University regulations, reports to the Vice President for Student Services. The University Police Department in conjunction with Career and Counseling Services has numerous programs during the year to promote the awareness of rape, acquaintance rape and all other sex offenses. Sanctions following a disciplinary procedure for any offense including sex offenses are detailed in the Student Handbook and may include suspension or expulsion from the University. Upon request to the hearing official, both the accuser and the accused shall be informed of the outcome of any campus disciplinary proceedings including sexual assault cases. Counseling services, including resources available in the community, are provided by the Counseling Center for any student involved in a sexual assault. Any student involved in a alleged sexual assault incident will be given assistance by the Vice President of Student Services in changing academic and/or living situations. At CNU, safety is a primary consideration in the maintenance, groundskeeping, and lighting of the campus. If University Police officers should discover a broken window or non-functional light, they inform the Physical Plant Department.

The University is protected by a sworn police officer 24 hours a day, 7 days a week, 365 days a year. Located in Room 238 of the Campus Center,

the University Police Department is normally open Monday through Sunday, from 8:00 a.m. to midnight, however, a University Police officer can be reached at other times by dialing the 24-hour University Police emergency telephone number: (804) 594-7777.

Building Security

All University buildings are checked on a regular and on-going basis, and are secured by the University Police after their normal hours of use. Access to secured University buildings or other University facilities is restricted to individuals authorized to have keys or to those who hold valid passes for those buildings or facilities. All maintenance problems discovered by or reported to the University Police are reported to the University Department of Physical Plant on a priority level. All maintenance problems which could cause bodily harm or some type of other danger are reported immediately to a University Department of Physical Plant personnel supervisor or his/her appointee.

Law Enforcement Authority

University Police officers receive their professional training from the Hampton Roads Regional

Academy of Criminal Justice (mandated by the Virginia Department of Criminal Justice) and have arrest authority under the code of Virginia (1950: [17:23-234]).

As sworn police officers, CNU Police have authority to exercise the same powers and duties as city, town, and county police officers. In cases where University Police resources cannot meet a particular need, the Newport News Police Department or the Virginia State Police are called upon for assistance.

Security Awareness and Crime Prevention

University Police officers document security and safety violations found during their routine patrols of buildings and grounds on a Safety Notice form. The form is sent to the person responsible for the violation and correction of the problem is solicited. Crime prevention lectures and programs are scheduled for each semester for all students, faculty, and staff, and crime prevention materials are made available in the offices of the University Police Department. Crime prevention material is also made available at all freshman and transfer orientation programs and to those requesting them from the University Police.

It is the policy of the Newport News Police Department to inform CNU Police of any arrests for violations listed above which have occurred on University property.

Reporting Crimes or Emergencies

The victim of a crime may report it to a University Police officer by visiting the University Police Department during normal working hours or by calling the University Police at (804) 594-7053 or the 24-hour emergency number, (804) 594-7777, or use one of the orange emergency call boxes on the campus. If a crime of murder, rape, robbery, aggravated assault, burglary, or motor vehicle theft occurs and there is a potential for continuation of the crime, a notice of warning of the crime will be posted at the main entrances of each campus building. It is the policy of the University that all criminal acts are reported to the University Police Department. The immediate reporting of any crime, especially sexual assaults, assists in the preservation of evidence necessary to convict a person involved in such criminal activity.

Possession, Use, and Sale of Alcoholic Beverages

The University Police Department actively suppresses the illegal possession, use, or sale of alcoholic beverages. Violations of this nature are dealt with by summoning the individual(s) to court or issuing the individual(s) a student summons to appear before the Director of Student Life.

Possession, Use, and Sale of Illegal Drugs

Anyone found in violation of any state of federal drug law will be summoned to appear before the appropriate court of law or given a summons to appear before the Director of Student Life.
