Violations of the Code for Academic Work

It has come to the attention of this office that research and term paper assistance services have been advertised in the Captain's Log and posted on campus bulletin boards outside of classrooms. Any use of these services by students for coursework may constitute an infringement of the CNC Code for Academic Work or a violation of the Code of Virginia or both. All faculty are requested to advise their students early in the semester of the relevant policy as contained in the College and Student Handbooks, which states, in part:

A student who obtains credit for work, words and ideas which are not the products of his/her own effort is dishonest, and his/her behavior has an adverse influence on the standards of the College. Because this is so, willful infringement of the Code for Academic Work entails severe penalties ranging from failure in cousework to dismissal from the College.

A student's name on any written exercise (theme, report, notebook, course paper, examination) is regarded as assurance that it is the result of the student's own thought and study, stated in his/her own words and produced without assistance, except as quotation marks, references and footnotes acknowledge the use of other sources or of assistance. In particular, the use of purchased term papers or research for submission as one's own work is expressly forbidden.

Professor Rodrigo Carazo

Professor Carazo is currently an international visiting scholar at Christopher Newport College. While here he is advising us on the development of our Latin American Program which is part of the College's overall initiative in International Education and is teaching courses in international relations for the Department of Political Science and Governmental Administration.

Professor Carazo is a Ph.D. candidate at Geneva's Graduate Institute of International Studies (Inst. Univ. de Hautes Etudes Internationales) and comes to us with extensive academic and professional experience in international relations. He possesses degrees in law and economic studies from the University of Costa Rica and a Certificate of Advanced Studies in Political Science from Geneva's Graduate Institute of International Studies. He has taken courses at the Hague Academy of International Law and has done post-graduate research at the Center for Latin American and Caribbean Studies at Indiana University. His teaching and research interests involve the current social, economic, and political conditions of Latin America and the international relations between Latin American nations and the United States.

At the professional level, he has been an advisor-at-large to various corporations, an informal advisor to the President of Costa Rica and a special ambassador of the President to the United States and other governments. He has travelled extensively in Central and North America, parts of South America, most of Western Europe, the Near, Middle, and Far East, and North Africa. He is fluent in Spanish, English, and French and is learning German.

Professor Carazo was born in Costa Rica, is married, and is the father of four daughters. While at Christopher Newport College, he and his family are living in Newport News.

COMMITTEE REPORTS

Potentially Copyrightable Work

The College Handbook (II, 21ff) describes in detail the college policy in relation to the determination of copyright ownership. The key sentence describing employee responsibility in this matter is: "All materials in which the College may have a proprietary interest under the provisions of this policy shall be promptly reported in writing by College personnel concerned, through their department head, to the Copyright Subcommittee." (II, 21) The policy defines College personnel or employees as full- and part-time faculty; classified employees; administrative staff; and students who are paid for specific work by the College. The policy further states, however, that: "Copyrightable materials developed by College employees shall usually be the property of the employee." (II, 22)

Disclosures of all copyrightable materials should be made promptly to the subcommittee prior to submission of those materials to any other party. Two factors make it likely that the College will have an interest in given copyrightable materials: (1) When the materials resulted from a specific assignment to produce such and/or (2) When the production involved "substantial use" (a minimum worth of \$10,000) of college facilities and resources (not to include the library, the employee's office or laboratory, and salary). The Subcommittee on Copyrights will review the materials and make a determination of the College's proprietary interest, if any, in the product within 90 days after receiving the disclosures.

Disclosures should be made on a form available from the chairman of the subcommittee.
