

CEEB Plans Changes In CLEP for 1978 The College-Level Examination Program (CLEP) will be changed in 1978 to include the addition of a centrally graded essay section to the present all-objective general examination in English composition, and the

lengthening of all five general examinations from 60 to 90 minutes.

The College Entrance Examination Board, which announced the changes this weekend, said the five general examinations—English composition, mathematics, natural sciences, humanities, and social sciences and history—evaluate knowledge of liberal arts subjects acquired outside the classroom and account for approximately 65 percent of all CLEP examinations taken today. The remaining exams include 47 CLEP subject examinations in areas ranging from computers and data processing to western civilization.

The general examination in English composition will be offered in two versions—one with an essay and objective portion, and one with only objective questions. The essay, on a particular topic, will be timed at 45 minutes.



#### COMMITTEE REPORT

#### Faculty Evaluation Committee

#### Proposed Change to Faculty Evaluation Procedures

The FEC proposes that the following new paragraph be inserted after the present seventh paragraph on page V-4 of the <u>Faculty Handbook</u>:

The Chairperson of the Department receives materials for inclusion in the dossier of the faculty member. For inclusion, the materials must be relevant to some aspect of the faculty member's performance as determined by the peer group and must be signed and dated. The peer group verifies the accuracy of the materials. The purpose of the dossier is to provide the peer group and the administration with the objective information about the contribution of each faculty member. It is the proper repository for depositions bearing on a faculty member's performance; critical evaluations, whether complimentary or indicating areas in need of improvement, are included for objective evaluation.

#### Advantages of adoption (arguments for)

This provision will enhance the peer group's ability to make an objective evaluation in that the dossier will be more truly reflective of the faculty member's performance when the Chairperson has control over (and responsibility for) the material to be included in the dossier. Sources other than those provided by the faculty member concerned will become available to the peer group, thus providing a broader base for the objective evaluation. The requirement for signatures and dates on all material insures that the persons who provide dossier information can be identified and questioned for additional information or verification of allegations should the need arise. The faculty member will be fully informed of the sources of the information that is included in his dossier.

## Disadvantages of adoption (arguments against)

The faculty member is unable to control what information is included in his or her dossier. Although the source(s) of the information can be identified and questioned, it is possible that the faculty member's reputation and professional standing could be adversely affected through inclusion of unverified, negative or incomplete information in his dossier. The time and effort required to resolve issues generated by the inclusion of negative information over the objections of the faculty member outweigh any positive results to be gained. Furthermore, this proposal may lead to the inclusion of material from virtually any source—within and without the College Community.

Effect of adoption: as outlined in the advantages.

Effect of rejection: maintain status quo.
