

Authorization for Agency Purchases

The following memo has been received from Mr. Philip R. Brooks, Director of the Department of Purchases and Supply, Commonwealth of Virginia:

"It has come to our attention that some agencies are making direct purchases and purchasing off contract without the approval of the Director of the Department of Purchases and Supply.

In our continuing efforts for economy and efficiency in State government, we would like to remind you that these practices are not in accord with our goals or with the legal authority of the Department of Purchases and Supply, agencies, and institutions of State government. A copy of Section 2.1-273 of the Code is attached for your reference.

In order that these purchasing responsibilities can be fully understood, I would like to request that you forward us a list of the names of those individuals within your agency who are involved in purchasing. We, in turn, will send them materials that are necessary for their guidance."

Article 3. Centralized Purchasing

2.1-273. USING AGENCIES TO PURCHASE THROUGH DIRECTOR OF DEPARTMENT OF PURCHASES AND SUPPLY. -- Except as the Director of the Department of Purchases and Supply shall direct and authorize otherwise, every department, division, institution, officer and agency of the State, hereinafter called the using agency, shall purchase through the Director of the Department of Purchases and Supply all materials, equipment and supplies of every description, the whole or a part of the costs whereof is to be paid out of the State treasury; it shall be the duty of the Director to make such purchases in conformity with this chapter. (Code 1950, 2-249; 1958,c.124; 1966,c.677.)

GRANTS & FELLOWSHIPS

Graduate Fellowships for Minority Virginians

The Doctoral Fellowship Program for Minority Virginians is established under the <u>Plan for Equal Opportunity in Virginian's Institutions of Higher Education:</u> A Shared Responsibility.

The fellowship program is designed to assist qualified minorities who are employed in Virginia's state-supported institutions of higher education to pursue doctoral studies in one of Virginia's doctoral-granting institutions.

OBJECTIVES

The Fellowship program is designed to:

- 1. increase the number of minority faculty and administrative staff employed in predominantly white institutions by increasing the number of minority individuals possessing terminal degrees; and
- increase the proportion of minority faculty and administrative staff at Virginia's state-supported predominantly black institutions who hold doctoral degrees.

ELIGIBILITY

Persons eligible for selection to the fellowship program must:

- 1. be full-time permanent minority employees of Virginia's state-supported institutions of higher education (minority employees include those persons of the following ethnic categories: American Indian or Alaskan Native, Asian or Pacific Islander, Black not of Hispanic Origin, and Hispanic);
- 2. be employed as a faculty member or administrator with faculty status;
- 3. have earned a master's degree
- 4. be a citizen of the United States; and
- 5. meet the selection criteria stated below.

SELECTION OF PARTICIPANTS

The following criteria will be considered by the Council of higher education in the final selection of participants:

- 1. acceptance for admission into the graduate school of the Virginia doctoralgranting institution of the individual's choice;
- 2. a commitment to return to the employing institution for a minimum of two years or twice the period of study;
- 3. a commitment by the employing institution to rehire the participant in a position equal to or higher than his present position; and
- 4. a review of undergraduate and graduate transcripts and academic references testifying to the individual's intellectual capacity and educational attainment as indicators of satisfactory performance in advanced graduate work.

STIPENDS

- 1. The stipend for a participant will equal no more than half (with a minimum of \$5,000 and a maximum of \$8,000) the salary of the participant during the year immediately preceding his or her entry into the program. The amount of stipend might vary in accordance with the amount of additional state funds the participant might receive from salaries or other sources.
- 2. The stipend will cover one twelve-month period.
- 3. An additional allowance of \$1,300 will be granted to cover tuition, fees and books.

ADDITIONAL INFORMATION

The implementation of the fellowship program described herein is subject to the appropriation of funds by the 1976 Virginia General Assembly.

His short stories have appeared in such publications as the South Dakota Review, Prism International, Carolina Quarterly, Portland Review, and Quixote. His latest work entitled "The Student" appeared in the winter 1975 issue of the Carolina Quarterly. Chuck has also prepared a Guide to the Marshall Family Papers, 1762-1908, and A Survey of the Holdings in Medieval Studies in Penfield Library in collaboration with Donald Barden, a colleague at SUNY, Oswego.

At Christopher Newport Chuck will serve as Assistant Readers' Services

and Reference Librarian and will be on duty in the Reference Room from 9:00 A.M. to 1:00 P.M., Monday through Friday. He will also be available to give bibliographic lectures to classes at the request of professors.
