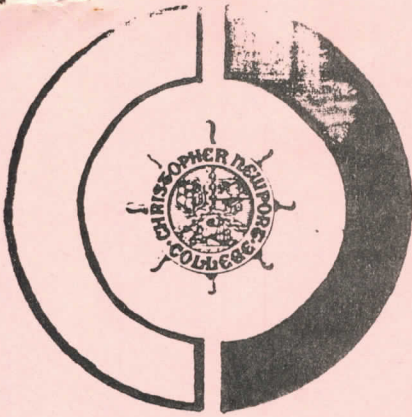

New IBM Copier

The IBM Series III Copier recently installed in the Duplicating Center is for the use of all authorized departments or individuals. The present machine will be replaced in July by a new identical model complete with a 20 bin sorter.

The lease/purchase of this copier is intended to relieve the Registrar's office and Library of duplicating responsibilities. However, it is not intended to replace the use of the offset press as an inexpensive method for multiple copies. Cost per copy on the IBM copier will be based on all overhead expenses such as monthly payments, service contract payments, monthly usage charge and cost of supplies used, divided by the copy volume. Based on these charges, cost per copy could range from .04 cents per copy through .08 cents per copy, which far exceeds offset press copy cost. Therefore, it would be advisable to continue to use the offset press for six or more copies and the copier for five copies or less.

Personal copies must be paid for in advance at the rate of ten cents per copy.

BSA Awards-Scholarship Program

On Thursday, May 3rd, the Black Student Association held its Annual Awards-Scholarship Program. The keynote address was given by Mr. Jack Gravely, Executive Secretary of the Virginia State Conference of the NAACP.

Awards were presented in three categories (Scholarship, Academic Merit and Outstanding Service). Two scholarships of \$200. each were awarded to members of the BSA with the highest cumulative GPA. The recipients were two seniors, Louisa Hill, an English major and James Tabron, a psychology major. Mr. Tabron has been accepted to the University of Virginia's Clinical Psychology program for this fall.

Certificates of Merit were awarded to seventeen students based on their overall academic achievement at CNC. Each recipient had a cumulative GPA of 3.0 or higher.

James C. Dinkins, a recipient from this category, will be entering the University of Stanford Law School this fall.

The final category of awards included certificates of appreciation given to seven members for outstanding support and participation. A plaque was awarded to Bonita Croom as the most active member of the Association.

REPORTS

Report from Faculty Senate of Virginia

On April 28, the FSV held its Spring meeting at VPI & SU (Blacksburg). Larry Sacks and Bob Durel attended from CNC. Larry presided over the meeting.

The major topics discussed at the meeting dealt with the work of several legislative commissions, namely, the Joint Legislative Audit and Review Commission and the Pickett's Retirement Study Commission which are studying the VSRS and the Schewel's Committee studying faculty grievance procedures. Delegate Bagley was present for a brief period and made comments relative to the General Assembly's concern with the VSRS and with the expenditures for the institutions of Higher Education in Virginia. Mr. Bagley is chairman of the House Appropriations Committee which oversees these expenditures. The FSV expressed concern over the low level of funding for VSRS and recommended that the state funding for VSRS be increased in future biennia.

Other topics included concern over the rise in the faculty-student ratio, the increase in administrative positions relative to faculty positions (some colleges/universities are cutting back on faculty while increasing administrators), and the continued lag between faculty salaries and inflation.

Elections of officers for the 1979-80 academic year were held. The new officers are: Charles Drake, VPI&SU, President; Jon Wilkins, Northern Virginia Community College, Vice-President; George Van Sant, Mary Washington College, Secretary; and Phyllis Stevens, Sweetbriar College, Treasurer. Bob Durel was elected to the Faculty Benefits Committee and will serve as chairman of that committee.
