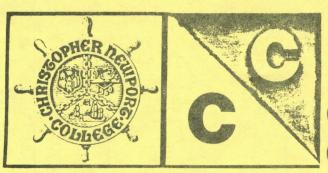

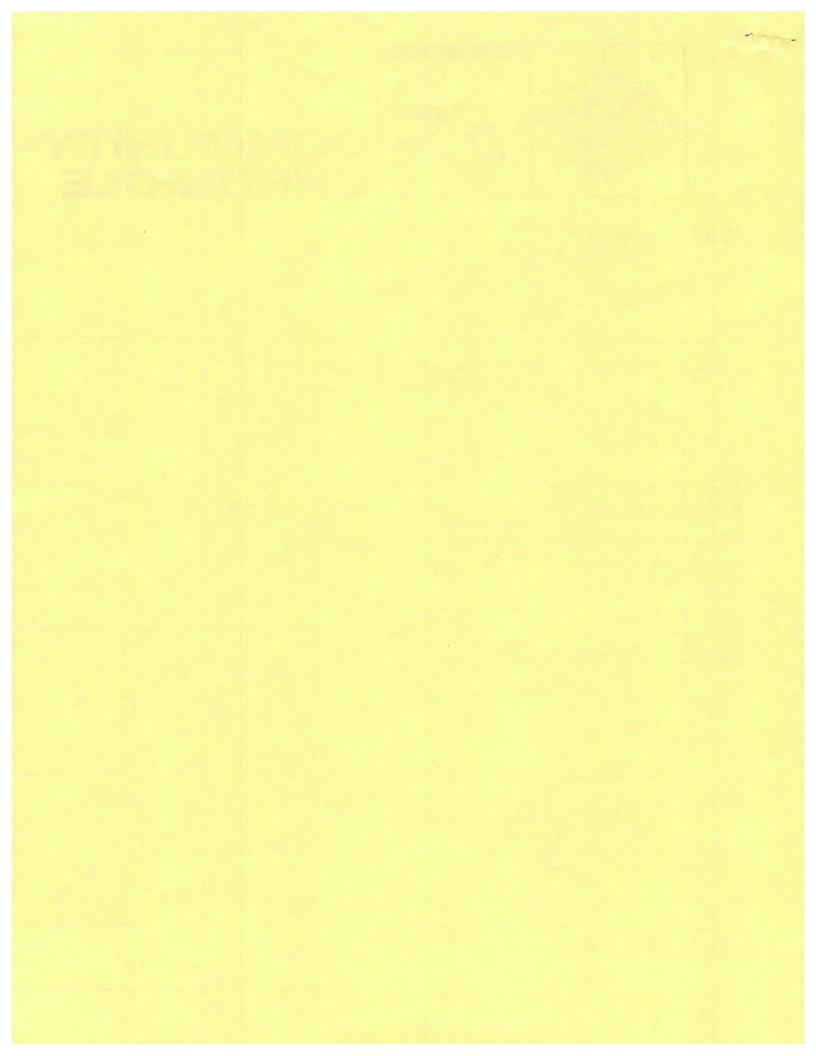

Position Opening - Dean of the School of Business and Economics

Christopher Newport College invites applications for the position of Dean of the School of Business and Economics, effective July 1, 1980. The Dean is responsible for the continuation of current curriculum, budget and program planning, instructional personnel considerations, and long-term development of undergraduate programs in business and economics leading to AACSB accreditation.

Earned Ph.D., or D.B.A. in Accounting, Economics, Finance, Management, or Marketing is required. A minimum of 7 years of successful college/university teaching experience, 3 years college/university administrative experience at the Department Chairmanship level or above, and commitment to a liberal arts philosophy are the requirements of the position.

Information on Tax Shelters

Recent changes in tax shelter laws have made it worthwhile for the mutual fund industry to enter the field. This year at least one of the no load funds is paying from 9.7 to 10.4% interest, and provides a check-writing service--provided checks are written for \$500 or more.

In addition to the <u>no load</u> advantage, tax shelter funds deposited with some of the mutuals are not limited by the "banded interest" provisions. This means that as interest rates rise, the interest paid on funds deposited earlier also increases.

Harry S. Truman Scholarship Foundation

The Harry S. Truman Scholarship Foundation provides college scholarships under a program established by Congress as the official Federal memorial to honor the thirty-third President of the United States. These scholarships are designed to provide opportunities for outstanding students to prepare for careers in the public service.

Harry S. Truman scholarships are awarded on the basis of merit to students who will be college juniors in the forthcoming academic year. To be considered, a student must be nominated by his or her college or university and meet the following conditions of eligibility:

- 1. be enrolled as a matriculated student pursuing a degree at an accredited institution of higher education during the year in which nominated.
- 2. be a junior pursuing a bachelor's degree as a full-time student during the year for which nominated.
- 3. have a college average of at least "B" and be in the upper fourth of the class.
- 4. be a United States citizen, or a United States national.

5. have selected undergraduate study that will permit admission to a graduate program leading to a career in government.

The proposal which follows has been formulated by a faculty ad hoc committee appointed by Vice President Edwards in September, 1979. A companion insurance program, to take effect at the time of expiration of benefits of this proposal, is being investigated but particulars are not yet available; therefore, the proposal will not be presented for faculty action until the November meeting, at which time full information should be available on the insurance program.

College Policy on Leaves for Maternity, Illness or Other Disability

It is the policy of the College to grant maternity leave or leave for illness or other disability with pay to a full time faculty member or a member of the administration with faculty rank when this becomes necessary during the period covered by his contract.

Except for members in their first academic year at Christopher Newport College, the maximum period of such leave is six academic months or until the end of the current academic year, whichever is longer.

For members in their first academic year the maximum sick leave period is six academic months or the end of their contract period, whichever is less. In this context "contract period" includes any period of contractual obligation extending beyond the first year.

Leave may be used when serious illness or death of a member's immediate family requires his or her absence from assigned duties.

A member who requests sick leave notifies or causes his dean to be notified as soon as possible of his disability and the estimated date of his return to work. The dean makes the appropriate arrangements that all assigned classes and other pertinent responsibilities to the member are met as scheduled. If the absence lasts longer than one week the substitute(s) are remunerated in accordance with current college pay scales.

5. If the absence lasts longer than two weeks, the member's illness or disability must be certified by the attending physician. This certification sets forth the nature of the illness or bodily injury, the diagnosis and prognosis thereof, and the approximate date of expected return to work.

After the faculty member presents such certification, the administration may request the member to submit to an examination by a physician mutually acceptable to the faculty member and the administration. The decision of such physician is binding on both the member and the administration as to the ability of the member to return to work.

7. Faculty members are encouraged to carry the group disability insurance which 'complements this policy. (Such a policy is being developed.)

Maternity leaves of absence without pay may be granted to members. Alternatively, members may take sick leave with pay in accordance with the provisions stated above.
