

Spring 1981 Registration Information

The following registration procedures were recently mailed to all students and are reproduced here for your information.

SPRING 1981 - EARLY REGISTRATION INFORMATION

November 17 - 21, 1980 - CAMPUS CENTER, ADMIRALTY ROOM

Enclosed is your early registration form for Spring 1981. Early registration is available only to currently enrolled students.

The schedule of classes will be published in the <u>Registration</u> <u>News</u> to be available by November 1, 1980 at:

- 1. Administration Building Lobby
- 2. Campus Center Information Desk
- 3. College Library

Billing statements will be mailed to early registrants in December. Tuition payment must be completed by mail or in person at the Business Office on or before January 9, 1981 at 4:00 P.M. Students receiving financial aid must also clear through the Business Office by January 9, 1981.

NOTE: Students who do not complete financial arrangements by the above date will have their registration cancelled and will be required to attend regular registration on January 20 and 21, 1981.

ONLY STUDENTS WITH APPOINTMENT CARDS MAY EARLY REGISTER

ALL EARLY REGISTRATION MUST BE DONE IN PERSON - NOT THROUGH THE MAIL

OBTAINING APPOINTMENT CARDS

Seniors who will have completed 85 or more credits by the end of the Fall term will early register by appointment on Monday, November 17, 1980.

All other students may early register by appointment between Tuesday, November 18, 1980 and Friday, November 21, 1980.

Pick up Appointment Cards at the Campus Center Information Desk beginning Monday, November 3, 1980. Present your adivsor signed registration form and you will receive your appointment card to admit you to early registration.

PROCEDURE

- 1. Arrange a meeting with your advisor before picking up your appointment card. He/ She will assist you in planning your course selections and sign your registration form. Choose alternate sections or alternate courses in case of closure.
- 2. Unclassified students registering for less than seven (7) credits may obtain an appointment card without an advisor's signature.
- 3. Pick up an Early Registration Appointment Card at the Campus Center Information Desk by presenting your completed advisor signed registration form.
 - a. Seniors will be given appointments for Monday, November 17, 1980, or later if they do not wish to take advantage of Senior Day.
 - b. All other students will be given appointments for the remainder of the week.

- 4. Present your appointment card at the proper time to the first station in the Admiralty Room with your registration form.
- 5. Your registration will be complete upon payment of your tuition.

President's Notes

A review of the available spaces on campus has been made. Of especial interest is the re-evaluation of the need for a faculty lounge. The conclusion is twofold. One, there is a need of some immediacy. Second, the logical location is available. Consequently, the office complex currently occupied by the President will become the Faculty Lounge as soon as the four-story building and the renovation of the present administration building are complete. A complete allocation report will be forthcoming.

State Evaluation of Educational Programs

The following article is an excerpt from the <u>Virginia Council</u> of <u>Higher Education Report</u>, Vol. 1, No. 3, October 1980.

Seminar Held on Educational Issues

State evaluation of the academic programs offered by Virginia's state-supported institutions of higher education was a major topic of discussion at a seminar held recently in Charlottesville by the Council of Higher Education. The seminar was attended by Council members and three guests, Dr. Winfred Godwin, President of the Southern Regional Education Board, Dr. Robert O. Berdahl, Director of the Institute of Higher and Adult Education at the University of Maryland, and Dr. Frank L. Hereford, President of the University of Virginia.

The Council and guests discussed a wide range of issues confronting higher education in Virginia and across the nation. Among them, the evaluation of academic programs emerged as the most lively topic. Stable enrollments and funding have brought about increased interest in the quality of higher education in the United States, and the evaluation of academic programs is widely viewed as one of the most pressing needs in higher education today. Furthermore, the periodic evaluation of all activities of state government has been mandated by the General Assembly in its program budget legislation.

Dr. Gordon K. Davies, director of the Council of Higher Education, reported the formation of a task force consisting of six public college representatives, a Council staff member, and a representative of the Department of Planning and Budget, which will draft guidelines to be used in program evaluation. Guidelines should be ready by the end of the current fiscal year so that preparation for evaluation can begin during the 1982-84 budget period.

Doctors Godwin and Berdahl confirmed that the quality of higher education is of increasing interest to taxpayers and state governments across the south and the nation. As a concluding note to the discussion, Dr. Davies commented that "evaluation at the program level can be valuable for Virginia's institutions, but it should be done by the people sensitive to the academic enterprise."

Increased Computer Capability

In support of better academic computing and more efficient utilization of our equipment, the Computer Center has moved some Data 100 equipment from the warehouse to the Computer Room. This new addition to the system hardware is being used as a Remote Job Entry station to the IBM-370 at The College of William and Mary. Since the Data 100 includes its own card reader and printer, a significant bottleneck at the HP printer has been cleared up. The Data 100 eliminates the use of the MRJE subsystem which has been a tremendous burden to the on-line users of the HP system especially during peak hours of usage.

In order to avoid any inconvenience to some users who may still use MRJE, two runs are being scheduled at 6:00 P.M. and 8:00 P.M. each evening until the end of this semester at which time this subsystem will no longer be supported. I discourage new users from using MRJE.

Inauguration, November 8, 1980

As the Inauguration Day comes nearer, its significance to the College is made more manifest. Using the response of our invited guests as a measure of significance, I am pleased that 350 people will attend the morning Symposium; 500 people will eat lunch with us; and 750 people will join in the Inaugural Ceremony and Reception -- this is the largest response ever accorded to the College. The guests include Governor and Mrs. Dalton; Secretary Walker; members of the General Assembly from throughout the State; members of the State Council; representatives of the governments of Tidewater Cities and Counties; the presidents and officers of the major banks, businesses, and industrial organizations of the Tidewater; and the presidents and officers of the major civic and professional organizations of the Tidewater. In addition, 45 universities and colleges are sending official delegates, as are 7 learned societies. Among the schools sending official delegates are Montana State, the University of Oklahoma, Ohio State, MIT, Harvard, Yale, Johns Hopkins, the University of North Carolina at Chapel Hill, North Carolina State, and the University of Virginia. Many other schools have sent official greetings to Dr. Anderson and the College. The learned societies will be represented by the American Chemical Society, The American Statistical Association, The Association of American Geographers and The American Council on Education.

As announced earlier one of the nation's most celebrated scholar-teachers, Dr. William A. Arrowsmith, has accepted our invitation to give the keynote address for the Inaugural Symposium which will begin at 10:00 A.M. in the Campus Center Theatre. After his address and after a coffee break, Dr. Arrowsmith will engage in a dialogue with five of our faculty: Drs. Buoncristiani, Paul, Lopater, Daly, and Papageorge. Vice President Edwards will be the host for the entire symposium, with Dr. Morris serving as moderator of the dialogue. The Symposium will conclude at 11:45.

The noon lunch will consist of steamship rounds of roast beef, baked potato, string beans almondine, and cheese cake. The lunch will be served in both the Campus Center and the small gymnasium in Ratcliffe. There will be four serving lines, each accommodating 125 guests. Mrs. Fletcher of the Campus Center Food Service and her staff are working hard to make the lunch a nice affair.

The afternoon musical interlude will return us to the Theatre where baritone Cliff Williams will entertain us with songs drawn from the seventeenth and eighteenth centuries. Williams, a balladeer for Colonial Williamsburg, Inc., was the 1979 winner of the National Auditions of the National Opera Association and the second place winner of the 1980 Metropolitan Opera Auditions of the Middle Atlantic region. Cliff is appearing in CNC's production of Fantasticks, this and next weekend.

At 2:15, we will begin to organize for the Processional March and will do so in Gosnold Hall. The Schools will be assigned robing areas on the second floor of Gosnold.

The Inauguration is set to begin at 3:00 and to conclude about 4:15. Governor Dalton, Mayor Ritchie, Dr. Rollings, Dr. Millar, Miss Cipriano, and Mr. Johnson will bring respective formal greetings from the Commonwealth, the Tidewater, the Presidents of colleges and universities, the College, the Student Body, and the Alumni.

The Day will conclude with a champagne reception.
