

Dean's Colloquia

Dr. Jouett Powell's talk "Religions Foreign and Domestic: Can They Be Understood? will open the Spring Semester Dean's Colloquia. Dr. Powell, Associate Professor of Philosophy at CNC, will speak at noon on Friday, February 4, in the Campus Center Theatre. Dr. Powell received a B.A. from Baylor University in 1964, a Bachelor of Divinity from Southern Baptist Theological Seminary in 1967, a Masters in Philosophy from Yale University in 1970, and a Ph.D. from Yale in 1972. He has published articles in The Downside Review and Proceedings of the Group for the Academic Study of Religions as well as given talks at regional and national meetings of the American Academy of Religion. For the past two summers, the National Endowment for the Humanities supported Dr. Powell's work: in 1981 a Summer Seminar Grant permitted him to study the history of the study of religion at the University of California, Santa Barbara; in 1982 a Summer Stipend allowed him to explore anthropologist Victor Turner's study of cross-cultural analysis of ritual.

Please plan to attend this timely presentation and urge your students to join the audience.

COMMITTEE INFORMATION & FACULTY BUSINESS

Faculty Advisory Committee

1. The text of the FAC recommendation to Dr. Summerville concerning academic reorganization of the School of Liberal Arts, Sciences and Education is printed below.

As requested, the FAC makes the following two sets of recommendations relative

to the academic reorganization of the School of Liberal Arts, Sciences and Education:

- I. Academic reorganization should be deferred for a minimum of one academic year because:
 - A. The second annual reversion of state funding recently announced by Governor Robb will cause the institution to enact even more stringent fiscal restraints than those already in place and on the planning board. This does not appear to be the time to create a new administrative position.
 - B. The re-examination of the basic distribution requirements is just being initiated. A model with several schools could incorporate a more logical alignment of departments subsequent to a redefinition or reaffirmation of the present distribution.
 - C. The chairmen of the academic departments appear to be willing to operate within the same academic organization during this financial exigency. No problems with the continuation of the status quo have been articulated from those recipients of the administrative services.
- II. In the contingency that the reorganization occurs this fall as originally planned, the following recommendations are made:
 - A. After an examination of the various criteria upon which an organizational model could be based, one overriding criterion reveals itself. The selection of the model should be based on the most logical allignment of departments when <u>academic</u> considerations are the foremost criterion.
 - B. The search should be local.
 - C. The selections should be made with the fullest possible participation of faculty members from the relevant school.
 - D. The evaluation of the deans should provide for the fullest possible participation of relevant faculty members in a process guaranteeing anonymity. Annual evaluations should go directly to the Vice President for Academic Affairs for subsequent review by the evaluee.
- 2. At the January 21 meeting of the department chairmen and Dean Durel, the above recommendation was discussed and both sections were endorsed unanimously by all department chairmen who were present.
