Holiday Leave

The College will observe the following holiday schedule during the Fall Semester:

LABOR DAY-The College will be closed on Labor Day, September 7, 1987. This is an authorized holiday, and annual leave is not charged. Classes will meet but all offices will be closed.

THANKSGIVING-The College will be closed on Thanksgiving Day, November 26, and on Friday, November 27, 1987. Both days are authorized holidays and annual leave is not charged.

CHRISTMAS AND NEW YEAR'S DAY-The College will close at 12:00 noon on December 24, 1987, and remain closed until 8:00 a.m., January 4, 1988. All of these days are authorized holidays

with the exception of December 24, 1987. Traditionally, Governors have authorized State government offices to be closed for one-half day for Christmas Eve. Taking this practice into consideration, one-half day will be observed as Christmas Eve on December 24. If the Governor does not authorize the additional four hours of Christmas leave, four hours of annual leave will be charged for the afternoon of December 24.

Employees required for necessary services on the above holidays are eligible for compensatory leave.

Position Available - Director of Athletics

Christopher Newport College invites applications for the position of Director of Athletics. The College is a state-supported, urban, four-year comprehensive institution of higher learning with an enrollment of more than 4,000 students. Christopher Newport College is located in Newport News on Virginia's lower peninsula.

The Director of Athletics reports to and serves at the pleasure of the Vice President for Student Affairs and performs all duties as directed by the Vice President. The duties of the position include, but are not limited to, the following: (1) Administration, leadership, planning and supervision of the Department of Athletics which includes 17 Division III inter-collegiate teams for both men and women as well as intramural and recreational programs; (2) Monitor the academic performance of student athletes; (3) Supervise and evaluate personnel in the department; (4) Maintain compliance with NCAA, DIAC (Dixie Intercollegiate Athletic Conference) and College regulations; (5) Prepare budgets, data and reports for presentation by the Vice President for Student Affairs; (6) Facilities management and event scheduling; (7) Fund raising, marketing, promotions and public relations for the department (8) Direct recruitment of student athletes; (9) If appropriate, coach one major sports team in addition to administrative responsibilities; (10) Develop and maintain excellent relations between athletics, students, faculty, alumni and the community; (11) Foster a positive image for the College consistent with its mission.

Minimum qualifications include a master's degree in a related field, and three years experience in athletics at the collegiate level. Preference will be given to candidates with strong leadership potential, exceptional interpersonal and communication skills, a commitment to the student athlete, thorough knowledge of intercollegiate, intramural and recreational programs and a strong record of personal, professional and academic integrity. Minorities are encouraged to apply.

Social Security Numbers for Children Over 5

The Tax Reform Act of 1986 (section 1524) requires taxpayers to show a Social Security number for each dependent age 5 and over that they claim for tax purposes beginning with the returns filed in 1988 and later. The provision is designed to reduce tax evasion in cases where parents filing separate returns both claim the dependent for tax purposes, a growing area of revenue loss, according to Internal Revenue Service officials.

About two-thirds of all young people already have a Social Security number, Social Security officials report. Those who now have a Social Security number will not have to get another one. It is estimated that about 9 million additional persons will need Social Security numbers to meet the requirements of the new law. The agency normally issues about 6 million replacement cards annually.

Because of the possibility the huge volume of applications may create bottlenecks in Social Security offices, schools and community organizations are being asked to assist in taking applications for Social Security numbers. The Social Security office will provide more detailed information on the nearest place for applying for a Social Security number in the near future.

Parents may apply for a Social Security card for their dependents by phone, mail, or in person. They must complete an "Application for a Social Security Number Card" (Form SS-5). A person 18 or an individual born outside the U.S. must apply in person. In any case, proof of date of birth, identity, and citizenship or lawful alien status is required with the application. A public, hospital, or religious birth record can generally be used as proof of date of birth and citizenship. Acceptable proofs of identity include hospital or physician records, school records, vaccination certificates, welfare records, library cards, and membership cards in youth organization.
