Grants Info

The deadline to submit proposals to the "Travel to Collections Program" funded by the National Endowment For the Humanities (NEH) is July 15, 1990. This program provides funds for travel to collections (libraries, archives, museums, etc.) needed for scholarly research in the fields of history, philosophy, languages, linguistics, literature, archaeology, jurisprudence, arts, ethics, comparative religion and some aspects of the social sciences. Awards of \$750 are made in late November, to be used for travel between 12/1/90 and 5/31/91. (This program is also available with a deadline of 1/15/91, with late May notification for funds to be used between 6/1/91 and 11/30/91.) NSF's Division of Social and Economic Science is supporting research, doctoral dissertation work, research conferences and workshops, acquisition of

specialized research and computing equipment, group international travel and data collection. The programs includes are:

Whereas the faculty is responsible for short and long term curriculum development let it therefore be resolved that the Senate favors an immediate change in the Handbook to the effect that only duly-elected full-time faculty members be voting members of the Curriculum Committee.

B. The following motion was moved and passed:
The Senate shall review and approve the concept and formulation of the College's response to the Twentieth-First Century Report of SCHEV.

C. It was moved and passed that the following be placed in the College Catalogue for the foreign language requirement:

The minimum competency in a foreign language is to the 101-102 for that language. Competency can be demonstrated by the grade for the 102 course; by transfer credit from an accredited institution; by successful completion of the Modern and Classical Languages and Literature placement test; by CLEP examination; or by an acceptable score on the College Entrance Examination Board (CEEB).

For languages not taught at Christopher Newport College competency may be proven by any of the above means except the Placement test of the Department of Modern and Classical Languages and Literature.

B. Weber moved the nomination of the following :


