This is a telephone information service which provides telephone access to recorded information tapes on drug and alcohol-related topics.

How to Use the System:

1. Dial toll-free 1-800-552-3784.
2. Listen for the tone.
3. Select the message you wish to hear by dialing the code number listed to the left of the topics printed below.
4. If you want to hear another tape, wait for the tone and enter the next code.

The system is completely confidential. You do not have to leave your name or number. You do not have to talk to anyone. The call is free to anyone in Virginia, and the lines are always open, 24 hours a day, 7 days a week.

MEMORANDUM

TO: All State Agency Heads

FROM: Joseph L. Fisher - United Way Statewide Coordinator

SUBJECT: 1984 United Way Campaigns

It is the Commonwealth's position to support all local United Way campaigns. As Statewide Coordinator, I assist United Ways throughout Virginia in planning for the inclusion of state employees in their campaigns. We appoint local United Way state employee coordinators in many communities, and provide general assistance. I would appreciate your making known our position to your agencies and employees.

You received also a copy of the Governor's letter to employees and a request that it be included with the September 14 paychecks. Please allow me to emphasize that the reference to all employees means those in Richmond and those in agencies and field offices located away from Richmond.

Agency heads and senior personnel at locations other than Richmond should fully cooperate with local campaign officials by making available the opportunity for employees to contribute to the campaign. This is, of course, a personal decision by each employee.

State employees are only one of many groups in a community that are asked to support the United Way. I believe it reflects with great credit on the Commonwealth when we have a courteous and open attitude toward the United Way.
