IRS Social Security Taxes

Salaried employees of the College should note that Internal Revenue Service directives require the state to withhold Social Security Taxes (FICA) on the imputed tax value of the fringe benefit provided by payment of the state for the employees' coverage under the VSRS group insurance program to the extent such insurance coverage exceeds the minimum prescribed as tax exempt under the IRS code. If your annual salary is over \$25,000 you may expect this change in withholding to begin shortly. the moment of writing this announcement it is uncertain exactly when this withholding by the Central Payroll Office will commence.)

COMMITTEE REPORTS

Minutes of the Faculty of Christopher Newport College (Unapproved) - November 18, 1988

The meeting was called to order at 3:10 p.m. by Professor Bill Winter, President of the Faculty Senate.

Business

On behalf of the Degrees Committee, Professor Fellowes moved (second: Professor Dawson) that the already published list of candidates for graduation in December 1988 be approved pending successful completion of respective degree programs. Approved

On behalf of the Nominations Committee, Professor Weber nominated Professor Fontaine to fill the vacancy on the Academic Status Committee created by Professor Hunter's assuming the position of Dean of the School of Business and Economics. There being no further nominations, Professor Fontaine was elected by acclamation.

Reports & Discussion

Vice President Eagle reviewed plans for the upcoming session of the General Assembly, as well as other items, as follows:

- (1) The College is seeking 25 additional faculty positions (cost: \$1405000)
- (2) The College will be converting 14 staff positions from hourly to classified (cost: \$86000)

(3) There will be an effort to increase research grants

- (4) Phase 3 of the library (19000 ft²)--the College will seek \$2900000 to begin construction in the summer of 1989
- (5) Pre-planning for the dormitory is complete; planning is underway for a "state-of-the-art" facility; the College will go forward with request for funding in 1990
- (6) Our 5% increase in enrollment is the second highest in the state
- (7) Enrollment projections: 3232 FTE in 1988-89 with modest growth over the next five years (long-range projections not desired until January, but the College will be seeking to reach 95% of guidelines in relation to faculty position
- (8) It is too early to know exact percentage of salary increase for 1989-1990, but he estimated between 5 and 10% since we still need to reach the sixtieth percentile of our Peer Group

Professor Mollick: Will G-145 be improved? VPFA: Yes. After construction is finished.

Professor Mollick: Recommendations are needed from all faculty who teach in G-145.

VPFA: Agreeable to discussing existing problems to resolve them. Professor Morris: How many usable exits will there be in McMurran after renovation?

VPFA: Three. The regular exits will not remain blocked (of course, the elevator should be avoided in case of fire).

Vice President Maris described measures being taken in relation to the Office of Institutional Advancement:

- (1) Three searches are underway--Director of Public Relations, Director of Alumni Relations, and Director of Grants Development
- (2) Candidates have been chosen for interviews

(3) Faculty participation in the interviews is requested

(4) Emphasizes that Joann Barbour is working in Public Relations, so publicity efforts are continuing

Expenses Fund

Hats were passed to collect contributions for the Expenses Fund-to be used to send representatives to the Faculty Senate of Virginia, and to pay gifts from the faculty appropriate to occasions like retirements. If you have not contributed, please send your contribution, of as much as \$5, to Professor Winter as soon as possible.

Announcements

- (1) The I.E.S. is being administered earlier this semester, so that the results can be available in a more timely fashion.
- (2) The Faculty Senate will be sending a memorandum to each

department chair to learn how the department uses overload and adjunct appointments, in preparation for a vote on a resolution regarding the possibility of a trade of overload positions for new full-time positions. That vote should come at the February meeting of the Senate.

(3) Deliberations on Faculty Development Grants and Sabbaticals

are complete.

(4) The next meeting of the Faculty Senate will be at 3 p.m. on Friday, December 12, in the Campus Center Board Room.

The meeting was adjourned at 3:45 p.m.
