

The Dean's Colloquia

Few activities on the Christopher Newport College campus represent the College's commitment to scholarly endeavor as well or as visibly as the Dean's Colloquia. This series of presentations is a public affirmation of the importance of scholarly and creative activity to the well-being of the academic enterprise, and, as such, it should command the support and attendance of the academic community itself. We therefore believe that each colloquium audience should include not only the Faculty, but also large numbers of students whose values and interests, like those of their teachers, have been touched if not shaped by the spirit of scholarly pursuit. In a very real sense, faculty and student support of the Dean's Colloquia are measures, respectively, of our academic vitality and our educational success.

SCATS Traffic Flow Study

October 16, 1984

TO: Heads of State Agencies and Institutions

In December, 1983, the Department of Telecommunications began a major study of the State Controlled Administrative Telephone System (SCATS). Phase I of the project involved evaluating both voice and data traffic flow to identify opportunities for improving the efficiency of the existing system.

With the assistance of a consultant, Telco Research, Inc., traffic load and calling patterns of agencies and institutions were analyzed and it was determined that substantial efficiencies could be achieved by adjusting various circuits handling approximately 1.3 million calls per month. Based on the results of this study, the Department of Telecommunications/Department of Information Technology will, during fiscal year 1984-85, be making several adjustments to existing circuits. Additionally, the inter-state long distance system (WATS) is being re-engineered according to the measured traffic patterns. We do not anticipate any disruption in services while these changes are being implemented.

The technical result will be an optimal telecommunications system and a continued high grade of service. The major benefit for the Commonwealth will be cost stability for the remainder of fiscal year 1984-85 and for fiscal year 1985-86. Without implementation of the optimization plan, the cost for equivalent services would be increased by approximately \$3.8 million annually.

This represents only the first phase of a much broader State project aimed at developing a new Statewide voice/data communications network.

I look forward to your participation in this important project and will keep you informed of future progress and activities.

Dr. W. Blaker Bolling presented a paper entitled "An Analysis of Consumer Patronage Motives and Purchasing Patterns in Bookstores by Selected Socio-Economic Variables" to the Atlantic Economic Conference in Montreal, Canada. He also chaired the session on marketing and was discussant on a marketing segmentation analysis paper dealing with the personal computer industry. His paper has been selected for publication in the March, 1985 Atlantic Economic Journal. He and Dr. Algin King jointly published a chapter in a new book, Health Care: An International Perspective, International Health Economics and Management Institute, 1984. This was the result of a paper presented in Paris, France last year. Dr. Bolling also participated in the National Meeting of the Academy of Management held in Boston in August.

Dr. Rita C. Hubbard, presently completing a three-year term as an associate editor of Communication Education, a national Speech Communication Association journal, has begun duties as referee and consulting editor for Communication Quarterly, journal of the Eastern Communication Association.

COMMITTEE INFORMATION & FACULTY BUSINESS

Curriculum Committee Minutes - October 15, 1984

Present: Sanderlin, Powell, Olson, Mathews, Durel, Hunter, Royall

- 1. The minutes of 10/12/84 were approved as submitted.
- 2. History course proposals were distributed. Physics courses and History courses will be discussed on 10/22/84. The secretary will invite Dr. Webb and Dr. Morgan (or Dr. Mazzarella) to this meeting.
- 3. Curriculum Proposal Debates
 - A. An amendment to motion 3B in the 10/12/84 minutes was offered by Durel (seconded by Royall) and was passed on a vote of 6 to 1. The motion now reads:

 "The Sciences Degree area requires a two semester sequence in a different science selecting from Biology 101/101L 102/102L; Chem 103/105 104/106 or Chem 121/125 122/126; Phys 103/104 with labs or Phys 201-202 with labs: however, only Biology 213-315 may be selected for the BSN or BS in LSPE degrees.
 - B. A motion by Durel (second Powell) proposed that the Professional Studies Degree area require six hours, three in a professional ethics course and three from a choice of Speech 201 or Computer Science 210 (or another course in Computer Science at a higher level). This motion was amended by Royall (second Hunter) on a vote of 5 to 2, deleting the requirement for three of the hours to be in professional ethics. The motion resulting was passed on a vote of 6 to 1 and reads as follows:

 "The Professional Studies Degree area requires six hours to be chosen

from the following: Professional Ethics (Phil. 304, or 374, or 384), Speech 201, and Computer Science 210 (or another course in Computer Science at a higher level)."

- C. A motion by Powell (second Royall) was postponed by request of Olson (with committee agreement). The motion is: "The Letters Degree area requires nine hours, six in a modern language sequence and three chosen from either Speech 201 or Logic." The committee will return to this issue after gathering more statistics regarding the MCLL Dept (Dr. Powell to gather initial stats) and after debate on the Liberal Studies area.
- D. A motion by Royall (second Hunter) was passed unanimously and accepts the Curriculum Task Force Proposal, Area III on Physical Activities as written.
- 4. Meeting adjourned at 4:56.
