

#### House Joint Resolution 32

I have reproduced below a copy of HJR32, which was adopted by both the House of Delegates and the Senate of Virginia at the 1986 session of the General Assembly. This initiative has potentially significant implications for all libraries at the public institutions of the Commonwealth; but they are perhaps most significant (not to say most ominous) for institutions, such as our own, whose libraries have not yet reached maturity with respect to either holdings or physical facilities. Interested members of the academic community are invited to communicate their interest to the Director of the Council of Higher Education and/or appropriate members of the General Assembly.

#### HOUSE JOINT RESOLUTION NO. 32

Offered January 15, 1986

Requesting the State Council of Higher Education to investigate the academic library facility needs in Virginia's public system of higher education.

WHEREAS, the collections of academic libraries reflect the teaching and research 11 missions of the institutions of higher education and preserve the cumulative record of 12 human wisdom and knowledge; and

WHEREAS, the continuously growing collections of print, manuscript, and multi-media 14 materials create a constant need for additional library space; and

WHEREAS, many of the public institutions' library buildings now need additional space 16 to house existing collections, to provide quality reader space, and to support new 17 information technologies and modern library services; and

WHEREAS, the housing of little-used but still useful library materials in alternate locations, using compact physical storage or electronic storage, would release current 20 library stack space to house additional heavily-used materials; and

WHEREAS, recent advances in information technologies and the development of 22 electronic networks will affect both the organization and accessibility of collections as well 23 as the design of the facilities required to support academic library services; now, therefore, 24 be it

RESOLVED by the House of Delegates, the Senate concurring, That the State Council of 26 Higher Education for Virginia, with the assistance of the public institutions of higher 27 education, identify the library services needed to support the teaching and research mission of each level of institutions; investigate the feasibility, cost, staffing requirements, and 29 implementation process for adopting new forms of information technology that will increase 30 access to collections, improve library services, and support the storage and preservation of 31 valuable specialized materials; and develop a plan that promotes the effective and efficient 32 use of library facilities through the use of advanced technological support systems to 33 ensure full systemwide access to the library collections of Virginia's public institutions while 34 controlling the need for future library construction.

The State Council of Higher Education shall complete its work in time to submit 35 36 recommendations to the 1987 Session of the General Assembly.

# Minutes of the CNC Faculty Meeting of Feb. 14, 1986

The meeting was called to order at 3:30 by Dr. Summerville, the presiding officer.

- I. The minutes of the December 6, 1985 and the January 17, 1986, CNC faculty meetings were approved as reported in the Chronicle (#4 of 1986, p. 4).
- II. President Anderson briefed the faculty on efforts being made by members of CNC's administration and faculty to promote the best interests of the College and the community before the Virginia Legislature as it begins consideration of the Governor's budget proposal. He thanked those members of the faculty who have expressed their views to local legislators.

#### III. (Committee Reports:

- A. Academic Status Committee No Report
- B. Admissions Committee ---- No Report
- C. Curriculum Committee ---- No Report
- D. Degrees Committee ---- No Report
- E. Faculty Advisory Committee
  Dr. Gordon for the FAC mentioned that faculty had until Feb. 26,
  1986, to submit faculty development and release time grant proposals. He also noted that, although the committee had considered
  possible changes in final exam and outside employment policies,
  the committee continued to favor current policies.
- F. Nominations Committee ---- No Report
- IV. Ms. Royall briefed the faculty on the current status of the institutional self-study and noted that Dr. Douglas Smith, Chairman of the SACS Visitation Committee, will visit the campus on Feb. 17 and 18, 1986, to make preparations for the SACS Visitation Committee visit April 28-May 1, 1986.
- V. The faculty approved the Curriculum Committee's recommendation that Theatre 210-211 be considered a course sequence that meets the "Global View" criteria. The faculty voted to send back to the Curriculum Committee for further consideration its second recommendation that the College continue to accept PHIL 121, 122, 123 (from the community colleges) as transferring in as PHIL 101 plus lower-level electives, which would meet the Letters Degree Requirement but not one-half of the Humanities Requirement.
- VI. The faculty approved the recommendation from the Subcommittee on Commemoratives and Publications of the 25th Anniversary Steering Committee that "At the helm of the future" be the College's motto. The faculty voted to table the motion to approve "We Will Cherith Christopher Newport" as the official College song.
- VII. The faculty approved the recommendation from the Faculty Advisory Committee that the FAC be empowered by the Instructional Faculty to advise the president on matters regarding personnel in the event of a declaration of financial exigency during the current fiscal year.
- VIII. The faculty approved the nine student petitions submitted to the Degrees Committee.

- IX. Dr. Gordon announced that the Faculty Advisory Committee will communicate with the CNC Board of Visitors concerning the goals and objectives of the College. Dr. Summerville announced that Alpha Chi will be holding its Spring induction of CNC students at 3 p.m. on Feb. 16, 1986. Immediately following the induction will be a piano recital by Glen Winters.
- X. The meeting adjourned at 4:20.

#### Report of the Curriculum committee

- 1. The curriculum committee recommends that double counting of courses to fulfill the new distribution requirements not be allowed.
- 2. The curriculum committee recommends faculty approval of the following new courses:

FNAR 322 THEORY AND PRACTICE OF DRAWING (3-0-6)(cr.hrs-lec.hrs-lab.hrs)
Prerequisite: FNAR 218,219 or consent of instructor

A course of study in the development of a variety of approaches to drawing and their applications.

FNAR 360 WATERCOLOR (3-0-6)
Prerequisite: FNAR 218 or consent of instructor

This course introduces students to watercolor techniques through teacher demonstrations, studio setups and outdoor field sketching trips. Concentration is also directed toward a survey of materials as well as learning to use watercolor in conjunction with other media. A concern for design and composition in picture making will be stressed.

The Following courses are the upper-level nursing courses for our proposed Bachelors Degree in Nursing.

NURS 303 CONTEMPORARY NURSING (3-2-2)
Prerequisite: Junior standing or consent of instructor

Increases the student's knowledge of the nursing program's philosophy and conceptual framework. Enhances the student's understanding of major theories and concepts that serve as a basis for professional nursing practice. The student has the opportunity to gain enlightenment regarding

changes in nursing and related contemporary issues. The comprehensive role of the professional nurse is explored in relation to the changing health care system. Specific strategies and skills are developed by the student in order to assist the student to deal with the realities of professional challenge, present and future.

NURS 304 COMPREHENSIVE CLIENT ASSESSMENT (5-2-6)
Prerequisite: Nurs 303

Introduction to basic techniques of comprehensive health assessment of individuals at various developmental levels. Concepts from the behavioral, social and biological sciences will be utilized as a framework for health assessment.

NURS 305 NURSING RESEARCH (2-1-3)

Prerequisites: Soc 391, Nurs 303,304 or consent of instructor Introduction to the research process in nursing application. Emphasizes the conceptual background necessary to critically read and evaluate nursing research literature.

NURS 401 LIFE CARE IN REHABILITATIVE, CHRONIC AND LONG-TERM HEALTH CARE SETTINGS (7-4-9)

Prerequisites: Nurs 303,304,305 or consent of instructor Focuses on nursing strategies for tertiary prevention of chronic maladaptation due to disturbances in nutrient supply and elimination, mobility, oxygenation and regulatory responses to chronic maladaptive processes and aging and common intervention strategies for these processes will be analyzed and evaluated. The impact of chronic illness on the care and prevention resources and professional nursing practice will also be explored.

NURS 402 LIFE CARE IN VARIOUS COMMUNITY HEALTH CARE SETTINGS (7-4-9)
Prerequisites: Nurs 303,304,305 or consent of instructor

Focuses on the role of the nurse in a variety of community health care settings through application of nursing, family and community health theory to community health settings and situations. Assesses plans, implements, and evaluates nursing care with individuals, families, and groups in the community.

NURS 403 MANAGEMENT IN VARIED LIFE CARE SETTINGS (7-4-9)
Prerequisites: Nurs 401,402 or consent of instructor

Focuses on the nurse's management role in clinical nursing practice, the profession and the health care delivery system. Emphasis is placed on the decision-making process and application of management theory in a variety of health care settings. A general systems theory approach is utilized for analysis of management processes and problems. Change theory, strategies for conflict resolution, ethical and legal issues, and other relevant issues affecting nursing practice and the nursing profession are explored. Opportunity is also provided for enhancement of assertive and negotiative behaviors required in management roles.
