Holiday Leave

The College will observe the following holiday schedule during the Fall Semester:

LABOR DAY - The College will be closed on Labor Day, September 2, 1985. This is an authorized holiday, and annual leave is not charged. Classes will meet but all offices will be closed.

THANKSGIVING - The College will be closed on Thanksgiving Day, November 28, and on Friday, November 29, 1985. Both days are authorized holidays and annual leave is not charged.

CHRISTMAS AND NEW YEAR'S DAY - The College will close at 12:00 noon December 24, 1985, and remain closed until 8:00 a.m., January 2, 1986. All of these days are authorized holidays with the exception of December 24, 1985. Traditionally, Governors have authorized State government offices to be closed for one-half day for Christmas Eve. Taking this practice into consideration, one-half day will be observed as Christmas Eve on December 24. If the Governor does not authorize the additional four hours of Christmas leave, four hours of annual leave will be charged for the afternoon of December 24.

Employees required for necessary services on the above holidays are eligible for compensatory leave.

COMMITTEE INFORMATION & FACULTY BUSINESS

Approved Minutes of Curriculum Committee Meeting - November 5, 1985

Present: Olson (chairman), Bostick, Durel, Edwards, Hornik, Pellett, Powell, Summerville, Treacy (for Barbour), Turner, Weber

The Committee approved the minutes of the October 11 meeting with the stipulation that the following statement be placed on record: POLS 103-104 and HIST 111-112 have been approved by the Committee only as fulfilling the criteria for global courses; the Committee has not yet voted on whether to recommend them as new courses in the curriculum or as distribution requirements.

Vice President Summerville discussed some of the issues which will be raised at the November 15 faculty meeting. He also indicated that changes can be made in the new catalog as late

as February 1986. There will be a faculty meeting in February which will be a "last call" for approval of global view courses scheduled for implementation in the fall semester of 1986.

After discussion, the Committee decided on the following actions for the November 15 faculty meeting:

The Committee will move to take from the table the motion to delay for one year the implementation of the requirement in the proposed curricular structure for Baccalaureate Degree programs for two sequences of courses with a global view.

If the Faculty votes to delay the implementation of the global view requirement, the Committee will make no further motions. If the Faculty votes down the motion to delay, the Committee will then move that the following courses be accepted as global view courses: FNAR 201-202; MLAN 205-206; PHIL 201-202; RLST 131-231; and SOCL 201-202.

The Committee will also present the following information items to the Faculty:

1. Our operational criteria for global courses (in the minutes of the meeting of September 18, printed in the Chronicle of September 27).
2. The following proposed global view courses are currently under active consideration by the Committee: ECON 201-202; ENGL 207-208; HIST 111-112; POLS 103-104; THEA 210-211.

Dean Durel brought the Committee up-to-date on the request of the History Department to offer the B.S. degree. The State Council would like to review that request. It appears that the request will not require Council action but will require justification to the Council staff.

The Committee will continue its work on HIST 111-112 and POLS 103-104 at our next meeting: Tuesday, November 12, at 2:30, in N-202.
