I will be spending at least one day a month in Richmond and in Washington talking to administrators of specific programs in an attempt to aggressively pursue the procurement of grant monies for the College.

1. Fulbright Scholars-in-Residence Visiting Lecture Program
Application Deadlines:
December 1, 1982 - Junior Lectureships to France, Germany, Italy, Portugal, Spain
February 1, 1983 - Travel Award to France, Germany, Italy
2. 1983 Lindbergh Grants
Application Deadline:
November 16, 1982 - Grants of up to \$10,580 annually awarded to individuals whose proposed projects represent a significant contribution toward the achievement of balance between technological progress and the preservation of the nation's natural environment.
3. NSF Graduate Fellowships
Application Deadline:
November 24, 1982 - Three-year fellowships in Science and Engineering fields offered by the National Sciences Foundation. Open to college seniors and first-year graduate students at time of application.
4. National Endowment for the Humanities Fellowship Program
Application Deadline:
October 1, 1982 - Summer stipends for research or study in the humanities.

Fire Extinguisher Training

In accordance with Section 1910.157(g)(1),(2) of the Virginia Occupational Safety and Health Standards, a program shall be provided to educate and familiarize employees with the general principles of fire extinguisher use and the hazards of incipient stage fire fighting, where portable fire extinguishers are provided for employee use. The employer shall provide fire extinguisher training upon initial employment and at least annually thereafter.

On Thursday, September 16, 1982, a twenty-eight (28) minute film titled, "A, B, C's and D's of Fire Extinguishers," will be shown in Room 105 of the Administration Building. The film demonstrates how fire extinguishers function and shows how to use them, in suppressing small fires. It explains the necessity for using the proper types of extinguishers for various fires. The film will be shown once every hour. The first showing will be 8:00 a.m. and the last showing will be 4:00 p.m. All employees of the College should attend one showing of this film.

Flim Flam Fraud

An investigation is currently being conducted by the Virginia Department of Commerce into the possible flim flam, fraudulent operation of numerous groups of gypsy road pavers.

The method of operation of these groups consists of entering an area, residing at local motels or campgrounds, and soliciting the paving of private driveways and small lots.

The individuals offer the homeowners asphalt supposedly left over from a previous job and offer to pave their driveway for a fee. A thin coat of asphalt is then put on the homeowner's driveway with no preparation. The individuals then demand a large sum of money for their services.

In numerous cases, alleged intimidation has been used to collect from older citizens. The gypsy road pavers most often solicit from older citizens in rural areas.

Numerous vehicles and pieces of equipment are used in this scheme by the groups throughout the state.
