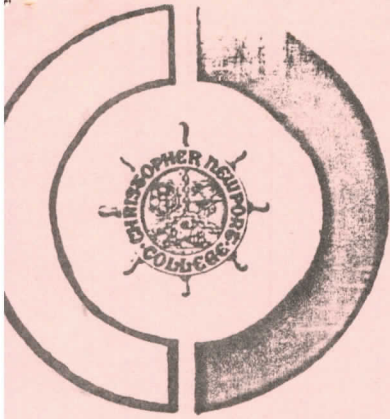

Barbara Mullens of Washington, D.C., and Gloucester, Virginia, will speak on the topic, "Toward the recovery of good feelings: An existential approach to psychotherapy." Dr. Mullens is in private practice as a clinical psychologist, is an adjunct professor of Psychology at American University, and consultant to the Psychology intern program at Eastern Virginia Medical School. She is considered Gestalt Therapist par excellence in the Washington area having studied with Fritz Perls.

LIBRARY NEWS

Guidelines for Counting Courses To Be Used in the Library Materials Allocation Formula

The Library Coordinators and Bette Mosteller have formalized guidelines for determining which courses will be included in the library materials formula. These guidelines are essentially the same as the unwritten guidelines which were applied in earlier years, but they have been refined and formally adopted for use. The guidelines will, of course, be subject to further clarification or refinement as the need arises. The guidelines are listed below for your information.

Definitions

Old Courses - Those courses listed in catalog.

New Courses - Approved by faculty during current year or not counted previously.

1. A one-semester course which is not hyphenated will be counted as 1 course.
2. A two-semester course which is hyphenated will be counted as 1 course except in the cases where it can be ascertained that different kinds of library resources are needed to support each semester's work. If there is any question as to what library resources will be needed, the coordinator concerned will contact the appropriate faculty member.
3. In making a count of the courses to be included in the formula, we will count all the courses listed in the catalog and not just the courses being offered during the year in question.
4. Old topics courses will not be included in those courses to be counted for use in the formula. New topics courses will be handled in two ways:
 - (a) Topics courses which will eventually become part of the curriculum will be given a separate grant of \$200.
 - (b) Topics courses which are ephemeral will be eligible for a grant of up to \$50 if the grant is applied for and justified.
5. Applied courses such as music or art will not be counted for use in the formula unless it can be demonstrated that they require library support.
6. Cross-listed courses will be handled in two ways. If a cross-listed course is taught by one professor, the course is counted in that professor's department. If a course is team-taught, it is not counted for use in the formula but may be eligible for a special grant if applied for and justified.
7. New major programs or concentrations will be given special grants as follows:
 - \$200 to \$500 grant as deemed appropriate will be given for new concentrations.
 - \$1,000 to \$1,500 as deemed appropriate will be given for new majors.
8. Independent or senior research courses numbered 399 or 499 and practicums will not be included in the count of courses to be used in the formula; however, all other courses listed as senior seminars will be counted. If necessary, the appropriate coordinator will contact the department head to determine the content of a course which is to be considered in this category.
9. An interdisciplinary major or program will be handled by assigning one of the coordinators to consult the individual responsible for the major or program to determine its nature and needs, and then such needs will be considered as a separate case and award made when deemed necessary.

The pre-registration materials have been sent to all current students. The Registration News will be available on Friday, April 13, 1979, in the Library, the Campus Center and the Lobby of the Administration Building.

PRE-REGISTRATION is Monday - Friday, April 23-27. The day time hours are 8:00 A.M.-3:00 P.M. in the Office of the Registrar, with evening hours of 6:00-8:00 P.M. on Monday and Thursday evenings only.

Please note the attached REGISTRATION FORM. There is NO course code anymore - the departmental prefix, course number and section designators key the new HP3000 CIS and it is of utmost importance that these be correct in order to assure proper data entry by my office.

Also, if there is any limitation on the student's enrollment it has been placed beneath the adviser's signature and above the student's signature, approximately 3/4 of the way down the form. (Note circled limitation on sample.)

Once again, I hope this pre-registration goes as smoothly as the Spring '79 one did. You, as advisers, can assure this.

BUSINESS OFFICE

Energy Conservation

We are in receipt of the Division of Engineering and Building's Directive #5, dated 3/21/79. The Directive was issued to insure compliance with Governor Dalton's program of energy conservation. I have extracted and stated below those provisions of the Directive which all State employees should be aware.

Cooling Season

1. Maintain the temperature of air conditioned spaces at not less than 78°F.
2. Do not operate air conditioning equipment in spaces that are unoccupied for several hrs.

Heating Season

1. Set thermostats to maintain maximum temperature at 68⁰F.
2. The use of supplemental heating units, such as plug-in electric heaters, should be avoided.

Lighting and Power

1. Lighting for ornamental purposes will be discontinued.
 2. Corridor and lobby lighting will be reduced.
 3. Persons must turn off lights when leaving their work areas.
