

Extension of Application Deadline

The last day that the Faculty Advisory Committee will accept applications for faculty development grants for this spring and summer has now been set at 9 March, 1979.

Divulgence of Individual Salaries

The Faculty Benefits Committee of the Faculty Senate of Virginia has requested a listing of the salaries by name for all faculty and administrative personnel of the College, and has made the same request of all colleges and universities across the state under the provisions of the "Freedom of Information" Act. This information will be supplied within a week.

Calculations of Faculty Members Rated By Departments Based on Student Enrollments

The following information as to how the number of faculty members rated by a department based on student enrollments is calculated is supplied in response to several requests. It should be noted that calculations for faculty rated are based on on-campus enrollments only.

A. Determining Full-Time Equivalent Students

Course Credit Hours x Number of Enrollees/15 = FTE Students

Example: 3 Credit Hours x 20 Enrollees = 60; 60/15 = 4 FTE Students

- B. Determining Faculty Rated (Except for Basic Studies, Terminal Occupational, Modern Foreign Languages, and Applied Fine and Performing Arts)

Lower level (based on course level)

Lower level student FTE's/20* = faculty rated

Example: 46 FTE students taking lower-level courses (100 and 200 level)/20* = 2.3 faculty members

Upper level (based on course level)

Upper level student FTE's/13** = faculty rated

Example: 46 FTE students taking upper level courses (300 and 400 level)/13 = 3.54 faculty rated

In the above examples, this department would rate $2.30 + 3.54 = 5.84$ faculty members.

- C. Determining Faculty Rated by Modern Foreign Languages and Applied (studio) Fine and Performing Arts

Faculty members generated by enrollments in courses which are given in English by the Modern Languages Department, and in strictly lecture courses in the Fine and Applied Arts Department are calculated as in B. above.

In foreign language courses and applied (studio) fine and performing arts courses the following ratios are used:

Lower level

Lower level FTE students/16 = faculty rated

Example: 12 lower level FTE students/16 = 0.75 faculty members

Upper level

Upper level FTE students/11 = faculty rated

Example: 27 upper level FTE students/11 = 2.45 faculty members

- D. Determining Faculty Generated by Basic Studies and Terminal Occupational Students

Total number of FTE students/15 = faculty rated

Example: 67 FTE Basic Studies students/15 = 4.47 faculty members

*In the 1980-81 academic year this divisor will be 21. In the 1981-82 academic year it will be 22.

**In the 1979-80 academic year and thereafter, this divisor will be 14.

"When dialing long distance (other than on-net SCATS calls) from a State telephone, you should dial '8', the area code, and the seven-digit telephone number. You should never dial '1'.

The telephone company has contacted my office, because many calls are placed daily using the '1'. The extra digit is creating troubles in the central office providing State telephone service.

GRANTS, FELLOWSHIPS, ETC.

Brookings Staff Associates (Employment
Policy) Program

The Brookings Institute has announced its program for Staff Associates in Employment Policy for 1979-80. This will be the fourth year for the program made possible by a grant from the U.S. Department of Labor.

Four scholars, from appropriate disciplines, interested in making research and administrative contributions to the resolution of national employment issues, will be selected to be Brookings Staff Associates. They will work for a year in the policy, evaluation and research offices of the Employment and Training Administration (formerly Manpower Administration) of the Department of Labor.
