

1. New first time students - unclassified students will have on their permanent record card the letters

UN in the upper left corner under the date of birth. When the student becomes classified the letters UN are removed and a notation "Admitted as a Degree Candidate" is typed on the transcript prior to the semester in which he/she becomes classified.

Students who enter the college as classified will not have the letters UN in the upper left corner of their transcript.

2. Transfer students - unclassified students will also have the letters UN on their transcripts. When they become classified their transfer courses are typed on the transcript instead of the notation.

Transfer students who enter as classified students will have their transfer courses as the first entry on the transcript.

Outstanding Faculty Award Program To: CNC Faculty
Date: November 29, 1989

The Council of Higher Education's Outstanding Faculty Awards program was funded in 1986 by the General Assembly to recognize the excellence of Virginia's public and private college and university faculties. Each year thirteen outstanding faculty members are honored for contributions made to their students, to their academic disciplines, and to the public.

The Council of Higher Education, using state-appropriated funds, makes a cash award of \$5,000 to each of the outstanding faculty members. In the first three years of the program, the Council has made thirty-nine awards to outstanding faculty from a pool of 311 nominations submitted by Virginia's public and private institutions.

A nominee for a Council of Higher Education Outstanding Faculty Award should have a current record of superior accomplishment in teaching, research, or public service. Since teaching is a principal focus at all institutions, particular emphasis will be placed on outstanding teaching accomplishments. The documentation submitted in support of a nominee should include details of the nominee's achievements and contributions in teaching, research, artistic accomplishment, public service, or a combination of these areas. Descriptive and evaluative statements from current and former students, faculty and professional colleagues, administrators, private and public sector leaders, and others should be provided. A significant part of each nominee's record of accomplishment should have been established since the nominee became a faculty member in the Virginia system of higher education. No fewer than four or more than eight of the awards will be made to outstanding junior or mid-career faculty, and no fewer than ten awards will be primarily for excellence in teaching.

The selection of no more than 2 nominees from CNC for this award will be done as follows: All faculty who feel qualified are invited to submit the material detailed below. The Executive Committee of the Faculty Senate will screen the applications in its meeting of January 9, 1990, and forward the top two to the VPAA. The material (in ten copies) should include: (a) a table of contents, (b) curriculum vitae, (c) documentation and evaluation of, as appropriate, teaching (include summaries of student and peer evaluations), research, artistic accomplishments, public service, or a combination of these activities, and (d) any other material deemed relevant in support of the nomination.
