

SUBJECT: 1978-79 TEACHER EXCHANGE PROGRAM

Opportunities will be available to teach overseas during academic year 1978-79 or to attend a seminar abroad during the summer of 1978. Teaching positions will involve interchanges with teachers from Canada, Germany, New Zealand, Switzerland, and the United Kingdom. A one-way assignment will be available in Denmark.

Summer seminars will be held for teachers of 1) art and art history in Belgium and the Netherlands, 2) German and German studies in Germany, and 3) classics and Italian in Italy. Subject to the availability of funds, seminars may be held for 1) teachers of world/Middle Eastern history in Egypt, 2) teachers of world/Asian history in India, and 3) social studies supervisors and curriculum directors in India and Pakistan.

Eligibility Requirements: U.S. citizenship; bachelor's degree; 3 years of teaching experience for the teaching positions, and 2 years for seminar grants for teachers; 3 years of experience for seminar grants for supervisors and curriculum directors; current assignment in subject field of seminar; fluency in German for Germany and in French or German for Switzerland.

The International Educational and Cultural Exchange program is authorized by Public Law 87-256 (Fulbright-Hays Act) and is administered by the Office of Education in cooperation with the U.S. Department of State. The seminars in Egypt, India, and Pakistan will be financed in foreign currency under Public Law 83-480.

COMMITTEE REPORTS

Faculty Advisory Committee

The following actions were taken at the FAC meeting on September 27:

1. The Undergraduate Student Cross Registration Procedures for the Virginia Tidewater Consortium as published below were reviewed. The FAC will move that these procedures be approved by the Faculty at the October meeting.

UNDERGRADUATE STUDENT CROSS-REGISTRATION

The purpose of undergraduate cross-registration is to provide opportunities for enriched educational programs by permitting students at any of the nine Virginia Tidewater Corsortium (VTC) institutions to take courses at any other VTC institution.

POLICIES:

- 1. Students at any resident VTC institution may register on a credit or audit basis for courses offered by other VTC institutions with the approval of the HOME institution.
- 2. When a student enrolled at one VTC HOME institution cross-registers to a VTC HOST school, the credit earned will be treated by the HOME institution as if earned at the HOME institution and will be so posted on the student's transcript as resident credit. A VTC institution will not issue a transcript to a cross-registered student which it hosts.

3. The grading system of the HOME institution must be used by the instructor at the HOST institution.

4. Tuition will be charged by the HOME institution for a cross-registered course. The cross-registrant must assume costs of all transportation, books, materials, lab fees, applied music fees etc.

5. Normally, the desired course must not be currently available at the student's HOME institution.

- This policy applies only to regular on-campus credit courses of VTC institutions.
- 7. Students will be governed by the administrative rules and regulations of the HOST institution while in attendance there.
- 8. A VTC Cross-Registration Form must be completed and signed by the appropriate people at the HOST and HOME institution. Where necessary, the student will certify that he/she has met course prerequisites.

9. Each HOST institution will establish its own dates for cross-registration.

10. Each member institution shall set up its own procedures for implementing these broad policies.

Rationale

Should these procedures be approved, our students will have the opportunity to register for courses not offered currently on our campus, and we will make our course offerings available to students at other institutions. Should these procedures be disapproved, we could not participate either as a HOME or HOST institution in the Virginia Tidewater Consortium program.

- 2. Subject to the Faculty's approval of these procedures and our participation in this cross-registration program, the FAC recommends to the Dean of Academic Affairs that students wishing to register for a course at a HOST institution complete a form secured from the Registrar's office stating the following:
 - 1. Student's name, major, advisor, date of graduation

- 2. Course to be taken
- 3. HOST institution
- 4. Date of cross-registration
- 5. Reasons for taking this course at a HOST institution rather than at CNC.

The form should be submitted to his major department for recommended approval or disapproval and then forwarded to the Dean of Academic Affairs. This procedure would serve as information to the appropriate department and allow input from the department, particularly in the implementation of procedure #5.

- 3. The Faculty Representatives to the Committee of the Board of Visitors briefed the members concerning the meetings on September 8. Topics discussed in the various meetings included the advising system, registration procedures, library hours, future building plans, the Annual College Fund Drive, and the operating budget for this academic year.
- 4. Bob Nason will be the representative to the Student Affairs Committee beginning with the next meeting of the Committees of the Board of Visitors.
- 5. The FAC will meet 11:00 A.M. 12:45 P.M. on Tuesday, October 11 to review the faculty development grant applications received by October 8. All faculty members submitting such applications will receive a written acknowledgement that the appropriate materials have or have not been received by FAC. Should you not receive such a form please call the Chairman of FAC. The first forms will be sent out by October 11.
