

Possession or Duplication of Certain Keys

As you go about your daily routine, you may occasionally need to work on campus at odd hours. It seems such a hassle to gain afterhours access to your materials or research. You may not have had a chance to talk to your professor about a letter of authorization; you might even know someone who has a key.

Before you borrow those keys, there's something you should know. It is a crime to have a key to any building or office on campus without specific authorization from a professor, department head, or staff supervisor. Article 18.2-503(a) of the Code of Virginia states, "No person shall knowingly possess any key to the lock of any building or other property owned by the Commonwealth of Virginia, or a department, division or agency thereof, without receiving permission from a person duly authorized to give such permission to possess such key.

(b) No person, without receiving permission from a person duly authorized to give such permission shall knowingly duplicate, copy or make a facsimile of any key to a lock of a building or other property owned by the Commonwealth of Virginia, or a department, division or agency thereof.

Violation of this section shall constitute a Class 3 misdemeanor.

Any student who has "inherited" a key to any college building or office is encouraged to turn it in to the Campus Police Department, and people who issue keys to students are advised to notify the campus policy, in writing, of the names and social security numbers of students authorized to have them (especially those who may be working after normal hours). A small convenience can quickly become a major liability!

SECRETARY OF EDUCATION MISSION STATEMENTS

Agency: Christopher Newport College (242)

Statement per 1986-88 Executive Budget:

Provide high quality instruction in the arts, sciences, business, and professional disciplines in an environment conducive to the development of an informed and productive citizenry.

Statement Recommended by Agency:

Christopher Newport College is a comprehensive, coeducational, urban institution of higher education offering graduate programs leading to selected Masters degrees. The College was chartered in 1960 as a part of The College of William and Mary; in 1977 it became an autonomous four-year institution, governed by its own Board of Visitors as a part of Virginia's system of public colleges and universities. On the Virginia Peninsula, Christopher Newport College is the college of choice for a broad spectrum of students — including those who enter directly from high school, those who transfer from other colleges and universities, and those who enter from the workplace.
