Minutes of the Christopher Newport College Faculty

May 13, 1983

The regular meeting of the Christopher Newport College Faculty was held May 13, 1983 in room 125 of Christopher Newport Hall. Vice President for Academic Affairs, Richard Summerville, presided.

CALL TO ORDER

The meeting was called to order at 3:05 PM.

APPROVAL OF MINUTES

The minutes of the April 8, 1983 meeting were approved by voice vote.

REMARKS

Vice President for Academic Affairs, Richard Summerville, addressed the membership as follows:

"Lest there be any uncertainty as to the significance of the elections that have taken place this week, it is important that the faculty understand the following points:

1. The persons elected this week are not now in any sense "senators," nor do they collectively comprise a senate. The College has no senate; and any actions taken by persons acting as a senate in advance of the date (if any) of the establishment of a senate by the Board or the President are, in the eyes of the College, of no effect.
2. The persons elected this week will comprise a faculty senate only if a body is brought into being by action of the Board or the President in a fashion and under conditions which are consistent with these persons being so designated.

3. If a senate is brought into being and if conditions of the kind in (2) do not obtain, then the senate will be reconstituted through processes consistent with the requirements of the action creating it."

ADJOURNMENT

The meeting was adjourned at 3:40 PM.
