

American Council on Education Cooperative Personnel Exchange Programs

If any faculty member is interested in either of the following two programs sponsored by the American Council on Education, please indicate that interest to Dean Edwards by March 18, 1977.

ACE Governmental Fellows

Through Title IV of the Intergovernmental Personnel Act (IPA) of 1970 (Public Law 91-648), Federal executive agencies are authorized to exchange personnel with state and local governments and colleges and universities. Sharing expertise, coordinating joint efforts, exchanging ideas, and

strengthening intergovernmental relations are the IPA's stated purposes.

Under agreement between the American Council on Education and the U.S. Civil Service Commission, the ACE Cooperative Personnel Exchange will select 20-25 faculty members and professional staff from member institutions for one- or two-year appointments in policy-level positions in the Federal Government. Assignments may be with Federal agencies in Washington, DC, or at regional offices; ACE Governmental Fellows will be assigned by Federal agencies according to their expertise. Some Fellows may have core managerial responsibilities, such as those involving budget, research, data processing, writing and editorial work, policy development and evaluation, equal employment opportunity programs, management and programmatic analysis, and personnel. Others may be concerned with scientific research, engineering, education, and social programs. Federal agencies benefit by being able to "borrow" expertise for set time periods and by establishing long-term contacts with the academic community. Assignees increase their range of experience by involvement in a new administrative environment.

Faculty members and staff from ACE member institutions are eligible to participate. Requirements include:

- Nomination by the president, chief academic officer, or senior officer designated by the president;
 - Full-time employment by the nominating institution;
 - Record of substantial professional accomplishment;
 - Evidence of expertise which could be utilized by the Federal Government;
 - Limited or no work experience with Federal agencies;
- Possession of appropriate professional credentials for the candidate's present post, normally meant to include college-level teaching experience and a generally recognized terminal degree;
- Evidence of benefits to the nominee and to his or her institution as the result of the Federal work experience; and
- Stated commitment by the candidate to return to the nominating institution after completion of the ACE Governmental Fellowship.

Nominees lacking these prerequisites but having compensating qualifications may be chosen. Race, sex, type of nominating institution, and other such factors will constitute no barrier to selection and placement.

ACE's Office of Leadership Development will collect and screen dossiers of nominees and a panel will select 20-25 finalists. After placement, which cannot be guaranteed, the finalists will be designated ACE Governmental Fellows. Other program details include:

- Each campus may nominate up to two candidates;
- The U.S. Civil Service Commission's Bureau of Intergovernmental Personnel Programs in cooperation with ACE will negotiate with Federal agencies about job assignments;
- Compensation for each Fellow will be determined by the Civil Service Commission and the participating Federal agency, using normal procedures. Salaries will vary according to the Fellow's experience, but will be in the general range of GS-12 to GS-15 (approximately \$19,000 to \$31,000).

Relocation expenses may be paid by the Federal agency. Arrangements will be made with the nominating institution for the fringe benefit package;

- · Nominating institutions must designate a liaison officer for each nominee;
- Conflict-of-interest or the appearance thereof must be avoided absolutely through adherence to Federal guidelines;
- As a supplement to the Federal work experience, the Fellows will be encouraged to reflect on higher education in its totality and their place in it through a reading program and contacts with national higher education associations and education agencies;

Higher Education Association Interns

The major higher education associations, most of which are located at The National Center for Higher Education, One Dupont Circle, Washington, DC, seek to identify faculty and staff members interested in brief association internships. The American Council on Education's Office of Leadership Development will broker these internships and recommend guidelines for their implementation. This is a free service available to professional employees of any U.S. college, university, consortium, or state coordinating agency.

Internships may last from one-to-twelve months. Interns could be involved in special projects or in routine association operations. The association will benefit through fresh input of ideas and

each intern will have an important Washington experience.

The Council will collect resumes for circulation to interested associations and provide guidelines. The associations will make their own selections and negotiate directly with nominating presidents on the nature of assignments, length of internship experience, and salary arrangements. Placement

with an association cannot be guaranteed.

Expressions of interest in this program should be noted on the enclosed form. This form should be returned to Dr. Thomas M. Stauffer, Office of Leadership Development in Higher Education, Association Internships, One Dupont Circle, Washington, D.C. 20036 (202/833-4763). Application forms are enclosed. All applications must be postmarked no later than April 1, 1977. The compiled list for circulation to the associations will remain active until the end of 1977.

Seminar and Field Study in England

The University of Virginia is sponsoring a Field Study Seminar at the University of London's Institute of Education in conjunction with the Third World Congress of Comparative Education Societies with a theme "Diversity and Unity Through Education." The Conference will be hosted by the Comparative Education Society of Europe. Participants in the program will have unique opportunity to attend this Congress and interact with experts from all over the world in addition to a special series of lectures and visits to various educational institutions prior to the opening of the Congress.

The proposed dates of the Seminar are June 20 through July 4 (with a possible extension through July 11), 1977. The cost of the program will be \$695 which includes air transportation, transfers, lodging (double room occupancy) including a continental breakfast, Congress registration, and seminars. ACADEMIC INTEREST

Faculty Recommends New Writing Requirements

A faculty committee at the University of Wisconsin at Madison has proposed major additions to the curriculum to insure that graduates of the university are effective writers.

A special committee studying the improvement of student writing suggested that all freshmen who test below a certain level in basic writing skills be required to take four to five credits of basic or intermediate writing. In addition, all juniors and seniors would be required to take an advanced writing program to be developed by their college.

RE: Amendments to the By-Laws

At the March Faculty meeting, the <u>ad hoc</u> committee will present our full report to the faculty. By early next week you will receive the reorganization of Section V of the <u>Faculty Handbook</u> in which the policy documents on promotions, tenure and reduction in faculty positions are integrated. At that time we will present a list of amendments to those documents which we feel are appropriate for reconciliation.

At this time we are presenting the following amendments to the By-Laws to bring them into accord with the policy on tenure approved by the faculty last May. Our By-Laws require notification of amendments one academic week prior to consideration.

I. Article V, Section 1.1:

AMENDMENT: Add Faculty Criteria Committee to list of elected Committees of the Faculty.

II. Article V, Section 1.2:

AMENDMENT: Add Faculty Criteria Committee to list of elected Committees that do not include the Dean of Academic Affairs as an $\underline{\text{ex}}$ officio member.

III. By-Laws, Article V, Section 8.3 (Handbook IV-4):

NOW READS: The Faculty Evaluation Committee shall receive all evidence collected by the department in support of the recommendation concerning a Faculty member's retention, promotion, tenure, and merit increase and

a description of the procedures followed in collecting the evidence and arriving at the decision. The committee shall certify that acceptable criteria have been established and procedures consistent with College-wide policies have been followed.

AMENDMENT: The Committee shall certify that acceptable criteria have been established, except in the case of tenure where this responsibility lies with the Faculty Criteria Committee, and procedures consistent with College-wide policies have been followed.

- IV. Article V, Add following sections:
 - Section 9.1: There shall be a Faculty Criteria Committee composed of five tenured representatives, one elected by each Division for a term of three years, with no member eligible for immediate re-election. No faculty member may serve on the Faculty Evaluation Committee and the Faculty Criteria Committee at the same time.
 - Section 9.2: The Faculty Criteria Committee is charged with the responsibility of studying the objective criteria established by each department for tenure recommendations and with making recommendations through the Dean of Academic Affairs where the need is indicated to bring about a campus-wide uniformity of criteria. Any subsequent changes in departmental criteria must be approved by the Committee.
 - V. An Additional Change to Section IV of Handbook:

Faculty Evaluation Committee - Delegated Authority (Handbook IV-7)

NOW READS: The Faculty Evaluation Committee receives a description of the procedure to be followed by the Peer Group in collecting evidence in support of its recommendations concerning retention, promotion, tenure, and merit increases and of the standards on which the recommendations are to be based. The Committee evaluates the procedures and standards with respect to consistency with College-wide policies and notifies the Peer Group, the evaluee, the Dean of Academic Affairs and the Chairperson of the evaluee's department of the decision, specifying any deficiencies.

AMENDMENT: The Committee evaluates the procedures and standards with respect to consistency with College-wide policies (except in the case of tenure where the Faculty Criteria Committee evaluates Departmental standards to insure campus-wide uniformity) and notifies the Peer Group, the evaluee, the Dean of Academic Affairs and the Chairperson of the evaluee's department of the decision, specifying any deficiencies.

Report from Committee on Degrees

The Committee on Degrees met on Friday, February 18, 1977, at 3:00 P.M., in the Conference Room of the Administration Building. Dr. Jones, chairman, presided. The Committee considered the following student requests:

 $\underline{\text{Case } \#1}$ Student petitioned to combine Sociology 200 and 319 to satisfy the social science distribution requirement. Departmental recommendation to approve this request is on file.

Committee action: The Committee would like Faculty guidance on cases such as this one. Should students be allowed to combine the first semester of a distribution requirement and an additional semester of an upper-level course in that subject to satisfy the distribution requirement? Although the Committee on Degrees obtains departmental recommendation in such cases, it is ultimately responsible for making a recommendation to the Faculty. The Faculty might wish to establish guidelines which would apply to such requests.

Case # 2 Student petitioned to take twelve of her last thirty-two hours elsewhere (these hours will be courses in her major). It was necessary for this student to leave the area.

<u>Committee action</u>: Based upon the recommendation of the department chairman, who is also her adviser, Committee recommended approval of this student's request in light of unusual circumstances.

Case # 3 Student petitioned to be allowed to receive the Associate in Arts degree with less than fifteen hours as a classified student.

Committee action: Committee recommended approval of request.

Case # 4 Student petitioned to use Philosophy 201 and Philosophy 308 to satisfy the Math/Philosophy distribution requirement.

Committee action: Committee recommended denial of this request.

Following the consideration of student requests, the Committee discussed Dr. Wildblood's motion that veterans be given P.E. credit for equivalent experience with the understanding that this policy would in no way affect the student's right to waive one distribution requirement. The Committee on Degrees has prepared a substitute motion for the Faculty to consider at the meeting on Friday, March 4; a memorandum containing this motion and arguments for and against adopting it was distributed earlier.
