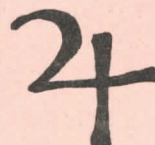

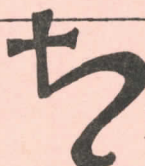

### Special Faculty Meeting

### Campus Visit of Health Profession Consultants

On Tuesday, April 20, Dr. Ralph Boatman and Dr. William Knisely will visit Christopher Newport College for an on-site review of our academic programs and facilities relative to possible new academic programs relating to health professions. Drs. Boatman and Knisely have been invited by a Tidewater Planning Committee that is working in conjunction with the State Council to develop a master plan for educational programs relating to the health professions in the Tidewater area. The consultants will be especially interested in discussing with faculty members our academic resources and potential in this area. The faculty Committee for the Health Professions is planning an itinerary for the on-site visit. I would like to encourage faculty members, especially in the Divisions of Natural and Quantitative Sciences, Social and Behavioral Sciences, and Education and Communications to meet with Drs. Boatman and Knisely on Tuesday afternoon between 3:00 and 5:00 P.M. Dr. Markusen, Chairman of the Committee on Health Professions has provided information to each department chairman concerning the visit of the consultants.

### State Council Defers Action

At its meeting in Lexington on April 6, 1976, the Council of Higher Education for Virginia voted to defer action on letters of intent granting approval for institutions to plan programs during 1976-77. The Council expressed concern over the extent and nature of information submitted with letters of intent, particularly confirmation related to the allocation of institutional resources and the projected cost of the program. This decision affects the CNC College B.S. and B.A. degree in Interdisciplinary Studies. I will be discussing this matter with Gordon Davies in Richmond on April 21, in view of the fact that our interdisciplinary degree requires no new courses, no new facilities, and no new faculty.

GRANTS & FELLOWSHIPS

UVA Fellowship Program

Two years ago the University of Virginia initiated a Graduate Fellowship Program which would enable faculty members at other four-year State-supported institutions who had not yet earned the highest graduate degree appropriate to their fields to undertake studies at the University. We intend to continue that program for the 1976-77 academic year and I am writing a letter similar to this one to the Presidents of all of the four-year State-supported colleges. Once again we will fund and support four fellowships of \$2,500 each.

As was the case last year, to be eligible for one of these fellowships an applicant must be a resident of Virginia, have the support of his college or university for the fellowship, and have been admitted to a graduate degree program at the University of Virginia. Applications for admission should go to the Deans of the Graduate School of Arts and Sciences, Engineering, Education, Graduate Business, or Nursing as appropriate. When the applicants for admission have been advised that they will indeed be admitted, they should write to me to apply for one of these fellowships. Their letter should be accompanied by a curriculum vita and supporting letters from administrators at their institution. I will then submit the applications for these fellowships to a committee to make the final selection. All data should be in the hands of David Shannon, Vice President and Provost, by May 19.

### Faculty Advisory Committee

The Faculty Advisory Committee thanks the members of the faculty who responded to the questionnaire concerning the composition of the CNC Board of Visitors.

The results of the questionnaire are as follows:

Number of responses: 50

1. Do you favor having a CNC faculty member on the Board of Visitors: Yes 39 No 11

If your answer is yes, please answer #2 & 3.

2. Should the faculty member be a full, voting member of the Board? Yes 23 No 14

3. Should the faculty member be a purely advisory member of the Board? Yes 16 No 19

Regarding specific faculty and non-faculty nominees, no significant consensus from the faculty emerged. All of the raw data, however, regarding specific faculty and non-faculty nominees have been forwarded to President Windsor.
